

## VIENNA/FALLS CHURCH ANNANDALE BABE RUTH D6 BOUNDARY

AGE 13 - 18  
1 JUNE 2019

Beginning at the intersection of Leesburg Pike (Rt 7) and the Dulles Access Road (Rt 267), proceed easterly and thence southerly along the south and west side of the Dulles Access Road approximately 4.0 miles to Idylwood Road/Kirby Road, thence easterly on Idylwood Road approximately 0.2 miles to Great Falls Street, thence southerly on Great Falls Street approximately 0.6 miles to Haycock Road, thence easterly on Haycock Road approximately 0.4 miles to Westmoreland Street, thence southerly on Westmoreland Street approximately 0.5 miles to the Arlington County line (located just north of 31<sup>st</sup> Street N, Arlington), thence southwesterly along the Arlington County line approximately 1/3 of a mile to the West Corner Boundary Stone, thence along the Arlington County line approximately 4.7 miles southeast and 0.1 mile south-southwesterly to the Alexandria City line located at the intersection of Rt 7 (Leesburg Pike/King Street) and Dawes Avenue, thence following the Alexandria City line southwesterly and thence southerly approximately 3.5 miles to where the Alexandria City line intersects Little River Turnpike (Rt 236), thence west-northwesterly along the north side of Little River Turnpike approximately 5.9 miles to Prosperity Avenue, thence northerly on the east side of Prosperity Avenue approximately 2.0 miles to Arlington Blvd (Rt 50), thence westerly on the north side of Arlington Blvd approximately 1.6 miles to Blake Lane/Pickett Road, thence northerly and northwesterly along the east side of Blake Lane approximately 1.0 miles to Interstate 66, thence westerly on the north side of I-66 approximately 2.9 miles to Waples Mill Road, thence northerly on Waples Mill Road approximately 0.8 miles to Fox Mill Road, thence northerly and northwesterly on Fox Mill Road, including both sides of the road, approximately 2.7 miles to a point north of Shady Tree Lane and south of Fred Crabtree Park, thence northeasterly approximately 2.2 miles to the intersection of Birdfoot Lane and Birdfoot Court, the line being drawn to include Stuart Mill Road and all streets connecting to Stuart Mill Road (i.e., Bridge Hill Road, the eastern segment of Foxclove Road, Yonder Hills Way, Donns Way, Vintage Crest Lane, Coulter Lane, Oakmont Court, Deville Estates Drive, and Birdfoot Lane), thence north-northwesterly on Birdfoot Lane approximately 0.1 miles to Lawyers Road, thence northeasterly, easterly, and southeasterly along Lawyers Road approximately 0.6 miles to Hunter Station Road, thence northeasterly and easterly along Hunter Station Road approximately 1.1 miles to Hunter Mill Road, thence northerly along Hunter Mill Road approximately 3.4 miles to Baron Cameron Avenue, thence northeasterly on Baron Cameron Avenue approximately 0.2 miles to Leesburg Pike (Rt 7), thence southeasterly along Leesburg Pike approximately 4.8 miles to the starting point at the Dulles Access Road.

The territory within the boundaries of leagues having a common border with Vienna/Falls Church Annandale Babe Ruth League (V/FCA BRL) are shared areas. Players residing in those shared areas may register and play in the V/FCA BRL with permission of the presidents of both leagues.
