


#### **Still Playing Off!**

### **Board of Directors Nominations Reminder**

There are 5 Board seats that will be up for election this year, 3 are for 3 year terms and 2 are for 2 year terms. As a reminder, below is the nomination procedure to run for an open Board seat per our Bylaws:

In order to be eligible to vote, nominate someone, or hold a BYHA Board position, you must:

- Be a BYHA Association member in good standing as stated in Article VI; and
- Be 18 years of age or older as of the date of the election; and NOT
- Be eligible to run for a Board position, or be a Board member in any other hockey association.

#### **Section 2: Nominations:**

The Board of Directors nominations shall be held at the March meeting only.

Nominations will not be accepted after the March regularly scheduled Board meeting. Written or verbal nominations will be accepted. At the end of the March meeting, the list of nominees will be officially placed on the election ballot. Nomination reminders will be published in the February and March newsletters. A written explanation as to why a nominee would like to be on the Board of Directors should be included with the nomination, which will then be published in the April monthly newsletter. This explanation is not to exceed 1 page in length.
