3) General Info

The season is upon us, games are being assigned; WSOA has assigned games through December 21. Mike will work with Mike Graham, and Tom Hanson for the Willmar schedule to plan my rink rotation for the season. We are identifying officials that would like to extend their officiating careers further than youth hockey and working with resources to advance their careers to the level these officials would like to take them. We are being aggressive with our mentoring and evaluation program again this season, that program has already begun.
