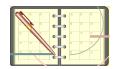

Board of Directors Nominations Reminder

There are 3 Board seats that will be up for election this year, and all are for 3 year terms. As a reminder, below is the nomination procedure to run for an open Board seat per our Bylaws:

Section 1: Nomination and Election Eligibility:

In order to be eligible to vote, nominate someone, or hold a BYHA Board position, you must:

- Be a BYHA Association member in good standing as stated in Article VI; and
- · Be 18 years of age or older as of the date of the election; and NOT
- Be eligible to run for a Board position, or be a Board member in any other hockey association.

Section 2: Nominations:

The Board of Directors nominations shall be held at the March meeting only. Nominations will not be accepted after the March regularly scheduled Board meeting. Written or verbal nominations will be accepted. At the end of the March meeting, the list of nominees will be officially placed on the election ballot. Nomination reminders will be published in the February and March newsletters. A written explanation as to why a nominee would like to be on the Board of Directors should be included with the nomination, which will then be published in the April monthly newsletter. This explanation is not to exceed 1 page in length.

• President's Report:

A big thank you to Dave Callicott for putting the Jr Gold Alumni game together – there was a great turn out.

• Secretary's Report:

Donnie motioned to approve the secretary's report, Cheryl 2nd, motion passed unanimously.

• Treasurer Report:

Any ice time in March will be a separate bill. An email will go out to get outstanding receivables in by February 10. Budgeting/finance committee needs to get formed and started. Suggested that perhaps starting a "Round Up" for scholarship fund.

• Registration Report:

Two coaches at the mini mite level have not paid their MN Hockey dues and will be pulled off the ice. Monica would like to see fees published by July 15 and have on line registration start by August 1.

• Tournament Report:

Missy reviewed the Girls U10A/U12A/U14A and Peewee B/C tournaments. Minor official training is imperative for the regional and state tournaments. Volunteers must go to training prior games. Ice time is set for the regional tournament. No info for the state tournament yet. Civic Center needs to have locks that work on locker rooms. Brenda will send a list of issues to the city. Next year Missy would like to have Tournament Director jackets for directors to use at tournaments. Tournament registration fees will need to increase next year. Next year t-shirts should all be pre ordered.

GOAL Report:

Kim presented what the SKATE program has been and what she would like to see it become. The national SKATE program is no longer. Now Kim proposes to change the name of the program to GOAL – Go On And Learn.

Fundraising Report:

Randy from Centra Sota was here to promote Community Lawn Care program. It was successful to the tune of \$1,725 to BYHA last year. We will be sending out the information again this year and hope to see even more success this coming year.

Bob Furneisen will coordinate BYHA in the Buffalo Days parade.

• Hockey Operations Report:

Player development - Jim Rooney will submit list of dryland items that are needed. Ed Roetheke and Bob Driver are talking with Crow River about the girls program for next year. Ed still talking with Elk River regarding a U14 combination team. Bill VanBergen asking for direction for definition of tournaments regarding home tournaments – should they be counted toward a tournament or not. Squirts did great in Grand Rapids – 4 wins, 4 losses and 1 tie. 8 and under program – letter from parents suggesting the development of a higher level mite team. HOC has recommended that there be a special event for 3rd graders at the end of year to get excited about squirts. Bob would like to have HOC and the Board together for a meeting early spring.

New Business:

We need to advertise for the finance committee – we would like to see representation from each level - 2 initiation, 2 squirt/U10, 2 from peewee/U12, 2 bantam/U14, and 2 Jr Gold and volunteer hours will be given to those who are on this committee. Please contact Cheryl Zitur if interested.

• Marketing Report: Nothing.

District 5 Report:

The Secretary report was accepted without delay or complaint. Treasurer's report shows a total account balance of \$48,480.38. Reminder that all fines must be paid in full before any teams are allowed to play in post season games. So, if there is an unpaid fine from any team at any level, all teams from the entire association will be prohibited from playing post season.

The travel policy was re-stated on the D-5 web site and reads as follows:

If weather conditions seem hazardous to highway travel and a coach questions the feasibility of traveling within the District 5 area, the following procedures should be followed:

- The Visiting team (the team traveling) coach must call Doug Kephart (320) 587-7768 or Tim Hanson (320) 235-9472. If neither Doug Kephart or Tim Hanson can be contacted, call Glenn Young (320) 693-8571.
- The call MUST be made by a Coach or Team Manager, NOT a parent.

Mr. Kephart and Mr. Hanson will retrieve information on travel advisories and make a decision on the game in question. If it is decided that the game should be rescheduled the association ice schedulers are responsible for coordinating a new game date. If it is decided that the game should be played, and the traveling team declines to play, the game will be recorded as a forfeit. The traveling team will also be fined for not playing a league game. This policy is contained in section V-B. of the District 5 Handbook. If a game is cancelled, the D-5 board member will call the home team and post the cancellation on the web site. Please remember, coaches or managers may call the D-5 board member. Parents should not call. Be sure that the coach and/or manager DOES NOT call the other team.

Zero tolerance policy is going fairly well district wide.

Girls coordinator Doug Foster would like the names, addresses, and phone numbers of all 1994 14 U A & B as well as H.S. girls who might be interested in the select team. Contact Doug about the details. His information is on the D-5 web site.

The D-5 tournament coordinator position is open for anyone who is interested. Contact Doug Kephart if interested.

If a team as a whole is infected, diseased, chronically ill, or otherwise taken down with sickness please call the D-5 folks to try to reschedule the game. Do not call the other coach.

Level 5 clinic will be in St. Paul on August 12-15, 2009. Go to USA Hockey web site for details.

LDC made a motion that 12 U games go to 15 minute periods rather than 12. The games would be 1 ¼ hours long since there would not be a re-surface. Motion to be voted on in April. This would only apply to the B teams since the A teams are in D-10 right now.

Sartell made a motion to allow mites to play outside of the district. Right now they cannot. Sartell's argument is that they are unable to play teams in St. Cloud that are across the river from them but they can play over 1 hour away in Mound. This does not seem to make sense. Motion to be voted on in April.

Motion by STMA, seconded by BYHA, to strike the D-5 mite move up policy and adopt the MN Hockey rules regarding mite move ups. D-5 allows up to 3 move ups. MN Hockey allows up to 1/3 of the squirt team to be move ups. The move up must play at the lowest level offered by the association. Motion to be voted on in April.
