Evaluations/Mentoring

Tom Lucken is the new Evaluation/Mentoring coordinator. We have 67 mentoring slots filled. Rick Nelson will be heading up the mentoring of our new officials, including our on ice clinic for new officials next season, and our mentoring during the mite jamborees. Rick is a D5 official; he works high school games for the St Paul Association and is currently a linesman for the WCHA Division 1 college hockey. We are fortunate to have his experience; Rick is excited about the potential of this very important program. We will once again use the Mite Jamborees as a mentoring tool. The host association will pay the normal fee for one official (\$17.00) the West Suburban Officials Association will add \$3.00 and will send two officials, each official will receive \$10.00 per game and WSOA will add the mentor and pay his fee. I will be in Willmar this weekend and will ask about working a similar program for their mite jamboree.

We have 60 evaluations completed; we will include our evaluations on The Arbiter now. This will allow us to post the evaluation on a secured area of the web site. This will be helpful, on the multiple evaluations we will be able to view what the last evaluator identified as areas that the official needed to improve. We will be able to see if the official is working those areas.

MHOA Meeting

The Minnesota district has 2733 registered officials that is an increase of 74 officials or 2.7%. We have 2351 officials that have completed all the requirements to officiate during 2008-09 season. This makes Minnesota the number one District for officials in USA Hockey.
