Secretary's Report: Presented by Kurt Lofrano, correction noted, new business #6, STMA motion and Buffalo second, reverse was noted. **Crow River motion; Hutch. second** – secretary's report approved.

Treasurer's Report: Presented by Robert Hantge, distributed report summary. Checking balance \$41,442.35, savings \$15,000. **MAML motion; Sartel second**, approve treasurer's report.

MN Hockey Report: Presented by Doug Kephart, distributed summary.

- 1) MN Hockey winter meeting (Jan. 23-25)
 - A. Region format ideas, D1, D4 and D5 in South Region this year, this is the last year of the current format, take back to associations for feedback.
 - B. District Directors re-examining district alignment, much discussion, likely nothing for next season.
 - C. USA Hockey Playing Rule Proposals initially over 80, approximately 20 passed along. Proposal on the floor within USA Hockey to prohibit youth and girls from icing the puck during a short handed situation. Doug would like association feedback for next meeting.
 - D. Player Numbers 60,417 total MN Hockey registered players and coaches, 2,771 players in D-5, 31 less than last season.

Game Reports

We have added nine new game reports.

One to a coach, under rule 404, the 15 penalty rule.

Eight of the new game misconducts went to players.

Four under rule 607 checking from behind.

Three under 613 Fisticuffs (one of these was a third man in rule).

One under rule 617 High Stick with an injury.

This brings our total of game misconducts for the season to 26. The most phone calls I receive are to dispute a check from behind call. This is a serious injury potential penalty that needs to be reduced, so my comments to anyone disputing a check from behind call is, would we be having this conversation if the player that was checked is being carried off the ice on a stretcher with the possibility of not walking again. Please ask your coaching staff to cooperate with all of USA Hockey in trying to remove this check from the game.

Evaluating/Mentoring

I was able to make it to Willmar again last weekend to evaluate a two younger officials and to watch a several others work. The Mite Jamborees will have a rotation of five officials at each game rotating through three games. Two young officials will be on the ice with a mentor, while one young official will be in the stands with another mentor discussing what is going on during the game. This was suggested by Rick Nelson, we are hopeful we will have enough officials and mentors to make this work well.

Post Season Games

We have a total of 40 District Playoff games scheduled, 39 officials have been assigned to these games. We are hosting the 12U A, and 12U B regional tournaments this season on the weekend of March 7 - 9, each tournament will have 15 games. I have all of Friday's games scheduled; I am waiting on two officials to commit to working that weekend before I can schedule the balance of the tournament.

We are blessed in D5 to have many good and young officials so choosing the state tournament crews was very difficult. I am happy to announce our four state tournament crews.

Old Business:

- 1) Playoff reminder weather policy, check website early and often!
- 2) Elections in April, Tim, Brian and Robert.
- 3) Current motions on table, any questions? Limited discussion, ALL TO BE VOTED ON AT APRIL MEETING:
 - a. 15 minute periods for 12uB. Friendly amendment by LDC- all 12u teams included, not just "B" if D-5 has a league at any 12u level.
 - b. PeeWee C reminder, current 15 minute period pilot expires, will also need to vote on for continuation in April.
 - c. Allow Mite level to scrimmage outside district. Validated motion is for entire district, no mileage restriction.
 - d. Amend D-5 Mite move up policy to follow MN Hockey policy but retain must play at lowest level, (2/3 of team must be age appropriate).

New Business:

- 1) Willmar presented, **motion**, if 15 minute periods for 12u passes, add a 15 minute resurface between 2nd and 3rd periods. Motion died, no second was made.
- 2) Buffalo opened discussion that they would like WSOA to handle all scheduling of officials within D-5. Initially a motion was made by Buffalo and second by STMA. Floor was open for discussion; Tim H. and Doug K. feel this would classify D-5 as an employer under MN law, MN state contractors of sports officials, researched in depth a few years ago. Motion dropped, not feasible based on state law.
 - a. Additional discussion continued with WSOA and Willmar concern. Perception of assignment of officials in Willmar. Due to location of Willmar, WSOA may have minimal impact on officials being scheduled.
 Scott Oeffling will try to get a WSOA representative to contact the Willmar board and report back to D-5 board.

- 3) Willmar presented, **motion Willmar, second STMA**, **add 15 minute resurface to 14u games**, table for now, vote on at April meeting.
- 4) Willmar presented, motion follows: "The District and associations shall provide equal treatment to boys and girls teams according to their age classification, which includes but is not limited to scheduling number of ice hours and time of day, equipment usage (such as goalie equipment provided by the association), number of tournaments teams are allowed to participate in, use of jerseys, and any other rules or restrictions the association places on teams". Motion died, no second was made.
- 5) Final score sheets have coaches/team managers review all standings, get score sheets in for last the last weekend. E-mail in last weekend scores and fair-play points to Tim Hanson and Mike Graham, follow up with hardcopy. Same for playoffs, all info. on website.
- 6) STMA presented, B1/B2 proposal. Discussed, MN Hockey will not allow or recognize. D-5 can adjust Squirt schedules if needed. Initial motion retracted.
