Old Business:

- 1) Elections Tim, Brian and Robert's positions are up for election in April, if interested, let an exec. board member know.
- 2) Neck guards observation from playoffs, approximately half of goaltenders did not have neck guards. If D-5 wants to continue policy, coaches and officials must enforce.
- 3) Plaques first and second place league winners, Glenn is missing names for a few teams, Bantam A Mound, PW B West River Lakes, 12UB, 3 way tie for second, need LDC Green and STMA, get names to Glenn.
- 4) Review of current motions, all to be voted on at April Meeting:
 - A. Implement 15 minute periods for all 12u level games within any league being offered within District 5.

- B. On a go forward basis, implement 15 minute periods for the Peewee C level, piloted this past season.
- C. Allow Mite level to scrimmage outside of district. Doug is asking motion to be removed as it is a direct violation of MN Hockey policy. Doug will work with Sartel on a situation waiver, **Sartel removed motion.**
- D. Amend D-5 Mite move up policy to follow MN Hockey policy but retain must play at lowest level, (2/3 of team must be age appropriate).
- E. WSOA to handle all District 5 scheduling of officials. Significant discussion, Tim distributed copies of information from Minnesota state labor statutes and the legal opinion received 4 years ago that D-5 would be considered an employer if mandatory use of WSOA officials. Doug also concerned with D-5 and mandatory use, Willmar has a mentoring program in place and Mike has been out 3 times for evaluations. Will look at game sheets and compare, such as penalties and fair play points. Motion remains for now.
- F. Add a resurface between 2nd and 3rd periods for 14u.

New Business:

- Playoff ice complaint from Crow River, time and driving location of some games. One possible way to alleviate
 for next season is to not post dates and times until teams are set, trying to keep teams closer to home
 (east/west sides of district).
- 2) A Grievance has been filed against the District 5 board, which includes a representative from each association and the executive board. The grievance was reviewed regarding the perceived disparity between girls and youth hockey. The grievance was heard by the grievance committee this evening.
- 3) **Motion by River Lakes, Willmar seconds:** If 15 minute periods for 12u passes; add a resurface between 2nd and 3rd periods. Will be tabled until April meeting to be voted on with other motions.
- 4) **Motion by MAML, Crow River seconds:** Accept Official's Game Fee Summary increases presented during the referee's report. Will be tabled until April meeting to be voted on with other motions. (please note, executive board members will abstain from this vote)
- 5) **Motion by Robert Hantge, Hutch. seconds:** District 5 to purchase one "sled" to donate to MN Hockey for use in disabled hockey league. Will be tabled until April meeting to be voted on with other motions.

Meeting adjourned at 9:12 PM, motion by MAML, STMA seconds.
