#### **Playoffs**

We used 40 officials for our District playoffs and 22 officials for the 12U A, and 12U B Regional Tournaments hosted by D5. To keep the officials fresh we used a one game per day format, there were two exceptions due to last minute scheduling changes. This seemed to work very well.

We sent four crews to state tournaments. All four crews skated on Sunday. JR Gold A tournament at Richfield, Brandon Geyen, Patrick Sebey, and Dom Clements skated the championship game. At the 14U B tournament at Marshall Kody Schantzen skated the third place game, and Brutger Mrozek skated the consolation game. At the 14U A tournament at Buffalo Brian McAvoy, Matt Stephens, & Darren Glur skated the third place game, and Rick Nelson, Michael Kephart, and Ryan Szymanski skated the championship game.

All the tournaments in D5 were organized very professionally, but special mention needs to go STMA for the 12U A Regional very well done. And to the ladies of Buffalo for the 12U B Regional, and the 14U A State tournaments. They have set a very high bar for how a tournament is conducted. Thank you all for your hard work.

### **Evaluations/Mentoring/Scheduling**

We completed about 170 evaluations, and 107 mentor slots, we had 38 new officials take games in D5. We assigned approximately 1800 games totaling about 3950 slots. Thanks to Tom Hanson, and Jeff Carlen for their efforts to be sure each games is covered by the correct officials.

I am always open for constructive comments on how we can deliver a better product to D5 youth hockey. Please let me know any comments you may have.

#### **Old Business:**

- 1) 12uA played 12uB discussed, purpose was to see if some of the B level teams can play at the A level. B
  teams did pick up the pace after skating with the A teams. Currently D-5 has 3 solid 12uA teams, will have a
  league if we can have 5 teams.
- 2) Voting on Motions ballots distributed to all association and executive board members, results below, all proposals passed.
  - 1) 14 Yes, 0 No, 1 Abstain: Implement 15 minute periods for all 12u level games within any league being offered within District 5.
  - 2) 11 Yes, 3 No, 1 Abstain: On a go forward basis, implement 15 minute periods for the Peewee C level, as piloted this past season.
  - 3) 9 Yes, 5 No, 1 Abstain: Amend the District 5 Mite move up policy to follow MN Hockey policy, but retain "must play at lowest level offered" aspect. (2/3 of team must be age appropriate).
  - 4) 13 Yes, 2 No, 0 Abstain: If 15 minute periods for 12u passes; add a resurface between 2<sup>nd</sup> and 3<sup>rd</sup> periods.
  - 5) 14 Yes, 1 No, 0 Abstain: Add a resurface between 2<sup>nd</sup> and 3<sup>rd</sup> periods for 14u league in District 5.
  - 6) 7 Yes, 3 No, 5 Abstain: Accept Official's Game Fee Summary increases presented at March meeting. (please note, executive board members will abstain from this vote)
  - 7) 13 Yes, 1 No, 1 Abstain: District 5 to purchase one sled to donate to disabled hockey league.
- 3) Season wrap up discussion If comments on weather policy, let Tim know, also Mike Graham is moving out of state.

### **New Business:**

- 1) Elections
  - President Tim Hanson, no further nominations
  - First VP Brian Johnson, no further nominations
  - Treasurer Robert Hantge, no further nominations
  - "White ballot", unanimous, all members re-elected.
