- 2. H1N1-Specifically, USA Hockey recommends:

  - b. Regularly wash hands.
  - c. Clean workout gear for each practice/competition
  - d. Keep gloves on during the traditional handshake with opponents.

You should be aware that symptoms of the virus include: fever (102 degrees Fahrenheit or greater), cough, muscle aches, runny nose, headache or sore threat, with potential for more serious complications, including pneumonia.

Transmission of the virus may occur from the day before the onset of symptoms and during the five to seven days that the symptoms are present. Infected Individuals should stay home until signs and symptoms have resolved, with no fever present for at least 24 hours.
