2. State Tournaments. PeeWee - Some complaints about using the 3-man system as the teams had not been exposed to this system during the regular season or play-offs. Mike Riley was not given a list of officials because Kris Walters was in charge of the tournament.

Bantam - Recommend that only referees be used as goal judges in the future.

Midget - Recommend that only referees be used as goal judges in the future. Maybe all minor officials should be referees.

Jr Gold - Major problem at the end of the game between Duluth and Grand Rapids. The referee was accused of punching a player. Investigation showed that the player spit in his hand and then shook hands with the referee. The referee then wiped the spit off on the players shoulder. No further action was taken.

Discussion: When does a referee's jurisdiction end?
Opinion is that it ends when players enter the locker rooms.

Ladies State - No problems.

Senior "A" State - No one knows who worked. We need to determine what action should be taken in the future. We will discuss in the fall.

3. MAHA Tournament Handbook. Bill would like input on any needed changes to the handbook.

Paul Moen asked which book applies? The MAHA Handbook overrules the MAHA Tournament Handbook.

* MHOA Officials Camp *

The camp will begin June 16th with arrival by 5:00 pm and conclude on June 20th. total cost of operating the camp will be about \$2,300.00, but by subtracting participant fees and fees from MAHA, the net cost will be about \$1,500.00 to MHOA.

Motion to hold the camp as outlined by Buzz Olson, seconded by Ted

The motion passed unanimously.

- a. Question: What if a District cannot supply a participant. Answer: Remaining Districts put in hat and one is drawn to replace.
- b. Notify Bill by May 15th of your selection.
- c. Criteria for selection.
 - 1. Must be a current Level 3 Official.
 - Should not be eligible for a USA Hockey Camp. 2.
 - Must be able to skate with Bantams. 3.
- d. Instructor staff to be selected by Bill and Dick Haney.

* MinnKota District Referee-In-Chief Report *

- The MAHA District Supervisor and Seminar Instructor lists were updated.
- The Playing Rules and Situation Handbooks were given to each Supervisor and asked that they be distributed to all Level 3 and Level 4 officials. Level 2 officials may receive a manual on request.
- Insurance Forms. The form must be completed by the official before sending to Dick.
- There has not been a decision on participants USA Hockey Camps. for camps this summer.
- There will be a MinnKota District camp at Duluth in September. 5.
- National Tournaments. When Minnesota is hosting a National Tourney, Supervisors should recommend their best officials to Dick so he can select a staff.

- 12. Dick will be staying as USA Hockey District R-I-C for 2 more years. Start thinking of a possible replacement.
- 13. Mark Rudolph will be married August 22nd.
