## Gambling Report

Gambling has about \$48,000 in checking. November income was about \$21,000. Clearing about \$4,000 - \$5,000 per month but taxes are on the increase. Continuing to move games and seems like things are trending better. Expecting about \$15,000 back from unsold tickets.

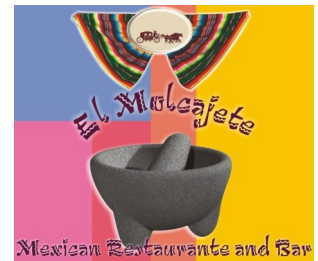
