Purchase made by Paige Lee, Treasurer. She ordered checks and checkbook cover and receipts that reached a total of \$161.41. Two signatures are required for balances over \$200 dollars.

A calling post was sent out to notify families of unpaid fees. A slip was also sent out with players a week ago. Tom Garin has helped by personally calling families to try and collect money. It was noted that some families are waiting for their tax returns to pay these bills. There are still (5) families that still owe \$5000.

Everything is now paid up for ice time.

President's Report:

The District10 meeting included all level directors and there was discussion around levels of play. Tim met with district level directors and talked about approach to level of play and what was learned and what will be done differently next year. It was noted that we had the choice to challenge our players at the higher levels or make it easier at the lower levels and we made an error to challenge them at the higher levels instead of having them skate at the B2 level.

Our teams need to be competitive.

There will be a joint board meeting scheduled in April to talk about what went well and what did not go well. This will also be an opportunity to discuss improvements for next season.

All of the legalities are done and to the lawyers for the Ice Arena. We now need to schedule a meeting with the city.

- Money for Disbursements We could do 5-7 thousand dollars.
 - The Association is required to maintain a certain level of balance with our account.
 Therefore, we disburse a percentage of the money we make from charitable gambling and give it back to the community.
 - o There are certain organization that have received donations from NBAHA
 - o Try to focus on the youth of North Branch Hockey
 - o We are required to give out 30%.
 - o A list of charitable organizations to donate funds to are listed below.
 - o It was noted that we should give back to the NB Library for the privilege of using their meeting room for all of our meetings
 - o The Blue Lion Club also supports our High School Program

- O Put out a proposal to the membership meeting to disburse funds to the community. The membership approves the disbursement. We did a gambling disbursement to offset fees to the tune of \$17000 for ice fees during the 09/10 hockey season. There was a vote to subsidize hockey fees with gambling funds to keep costs down at the Mite levels.
- Member asked if we have looked into setting up our own type of scholarship program for our youth hockey players. It was noted by the Board that there are a lot of things that the IRS requires for this to work. This is a touchy area and would require a lot of work to follow all of the rules and regulations. It was thought that it would make more sense to give money to a group that already handles scholarship programs and let them manage the work and liability.
- o Tim Cashill will follow up with USA Hockey on what they provide for scholarships.
- o Last year the association gave \$200 to several different locations up to \$1000.
- o The association usually will give 10% back to the community
- o The Board will discuss this further at the Board Meeting and bring back a proposal to the next Membership Meeting.

NEW Business
