- 2. FYHA Cell/Smart Phone possibility Looking at my personal phone usage, during the 8 month season, roughly 80% of my phone usage is FYHA related. I was wondering if the board would be willing to discuss a package that would allow me to get a blackberry or similar type of phone for making scheduling calls and keeping up on email when I am away from the office. I would not want to have 2 phones, so if they would be willing to set up some sort of plan that I could use for personal use as well, I would be willing to pay for a percentage of the calls I make for personal use. THIS CENTRAL SCHEDULING AGREEMENT (the "Agreement") is entered into as of _______, 2008, by and between Fargo Youth Hockey Association ("FYH") and Fargo All City Youth Hockey League, Inc. ("FACYH").

WHEREAS, FYH desires to provide various ice rental/scheduling services to FACYH and its various youth hockey teams at the Termite and Mite levels and various age groups of girls hockey.

WHEREAS, FYH is providing such services to FACYH as a request of the Fargo Park District to centralize ice rental for all youth hockey organizations in Fargo.

NOW, THEREFORE, FYH and FACYH hereby agree as follows:

- 1. Hiring of FYH It is hereby agreed that the FACYH is hiring FYH to provide the ice rental / scheduling services detailed below in the "Services Provided" section for the period of July 1, 2008 through June 30, 2009. FYH will assume the responsibility of hiring and maintaining a qualified employee ("Central Scheduler") to carry out the duties listed below in the "Services Provided" section.
- 2. Youth Hockey Organizations Utilizing the Central Scheduling Services provided by FYH: The services provided within this agreement will be provided to the following member organizations, only if those organizations ("Members") agree to pay the agreed upon scheduling fee (see section 5 below for details on the scheduling fee). Each of the following Members will appoint a representative from their organization to serve on a "Scheduling Committee" and be the contact and/or liaison between the FYH employee serving as the central scheduler and their hockey organization.
 - 1. Fargo Flyers Hockey Club
 - 2. Fargo North Raiders Hockey Club
 - 3. Fargo Angels Hockey Club
 - 4. Fargo All City Youth Hockey League, Inc.
- 3. Expectations of FYH employee responsible for carrying out the Central Scheduling Duties:
 This person must be able to and willing to work for each of these Member organizations in an unbiased manner, meaning that no organization or team within an organization will be given preferential treatment with respect to games, practices or tournaments.

This person will handle the day-to-day administration of scheduling all games, practices, and tournaments requested by each of the organizations listed above. The person hired in this position must be willing to work jointly with one representative from each of the four organizations listed above, and carry out each of their requests for practices, games and tournaments as best to their ability.

This person must be highly organized, detail oriented, and willing to expand upon and /or establish mutually

beneficial contacts / relationships with various hockey associations across ND and MN. In addition, this position will work very closely with the Fargo Park District to coordinate the ice rental time available to each of the youth hockey organizations and to enable the proper ice rental billings to take place each month.

4. Services Provided:

- a. Schedule all hockey practice times for each of the Members per the requests provided by the representative designated by each Member and serving on the Scheduling Committee. Priorities will be to schedule practices for teams based on their age group (ie: younger ages will practice from 4:00 pm to 6:30 pm, etc.)
- b. Use best efforts to honor requests from the Members to swap practices with other teams from
 any of the Members to meet requests for north-side practices and/or south-side practices (ie:
 FACYH termite team of North Fargo kids is scheduled to practice at Southwest Arena and
 Fargo Flyers Squirt B team is scheduled to practice at Teamsters swap these two practices to
 provide less travel time for each respective team)
- c. Schedule youth hockey games, both home and away, for each team within each of the Member youth hockey organizations (including both league and non-league games). Each Members' designated representative will bring the "game wish-list" to the Scheduler to provide suggested games that that Member would like its teams to play. Both the Central Scheduler and FYH do not guarantee that all requested games from each of the Members will be fulfilled and/or scheduled. Best efforts will be made by the Central Scheduler to fulfill game requests from each Member, then secondly will fill game requests through other contacts. It will be the responsibility of the Central Scheduler to efficiently schedule games to maximize the number of games to be played by each organization per their "Wish-list".
- d. Schedule each of the Members teams at various youth hockey tournaments per the request from each Members designated representative as to which tournaments their teams would like to participate in. Again, as with games, both the Central Scheduler and FYH do not guarantee that each Members requests for specific tournament participation will be fulfilled. However, the Central Scheduler will use their best effort to schedule each of the Members teams in the number of tournaments requested by each member.
- e. Each Member organization that hosts a youth hockey tournament in the Fargo-Moorhead area will still retain their own solicitation and marketing of these tournaments. The Central Scheduler will not have the responsibility or duties to assist the Members in finding youth hockey teams to participate within their own hosted tournaments (ie: Flyers Squirt International Tournament, Raiders Peewee Tournament, etc.)
- f. With respect to youth hockey tournaments for each of the teams within the member organizations, the Central Scheduler will also be presented with a "Tournament Wish-list" to enter each of the member teams into. In addition, the Scheduler will be looked upon to find quality tournaments for certain youth hockey teams to enter into based on requests from the representative from each Member organization
- g. The Central Scheduler will negotiate ice rental with other arenas in the surrounding area to meet the demand for additional ice rental needs for the Members that go beyond the ice rental times available in the Fargo Park District owned ice arenas and the Teamsters Arena. Such

additional ice rental will be negotiated with West Fargo Memorial Arena, Sunmart Arena, Moorhead Sports Center and Moorhead Youth Arena.

5. Fees to be paid to FYH:

- a. FACYH will pay to FYH a scheduling fee in the amounts detailed below for each respective team. These fees are for the 2008 / 2009 hockey season.
 - \$750.00 for each girls hockey team fielded at the U10, U12, U14, U16 and U19 levels.
 - \$65.00 for all girls hockey teams fielded at the U8 level
 - \$65.00 for each team fielded at the Termite level
 - \$65.00 for all mite teams that are not involved with travel (ie: traveling to games outside of the Fargo area)
 - \$250.00 for each team at the Mite level that is involved with travel hockey.
- b. The total fee as calculated in paragraph 5(a) above will be paid in three monthly installments to FYH beginning on December 1, 2008 and ending on February 1, 2009. The due date of each installment will be due around the 1st of each month, with an invoice to be provided by FYH approximately 15 days prior to the 1st of each month.
- c. If such scheduling fees are not paid within 20 days of the respective due dates, FYH reserves the right to cancel this agreement at any time.
- d. The scheduling fee will be remitted to the following address:

6. Other Items

- a. Each Member organization shall inform its members to refrain from the following activities:
 - i. Attempt to schedule games with other organizations without going through the Member organizations representative
 - ii. Directly contacting the FYH Central Scheduler relating to a scheduling (game or practice) issue. Any direct contact with the FYH Central Scheduler will be made by the Member's designated representative, and as such, communication from the families within each Member will be channeled to the designated scheduling representative.
 - iii. Directly contacting the Fargo Park District for any reason regarding the scheduling of a hockey game or practice.

7. Scheduling Reports:

- a. The Central Scheduler will use his/her best efforts to make available to each of the Members a practice schedule detailing practice times for the upcoming month by the 15th of each month (ie: practice schedule for December 2008 will be distributed by November 15th).
- b. The Central Scheduler will use his/her best efforts to make available to each of the members a listing of all upcoming hockey games for the 2008/2009 season for each of the Members by November 15, 2008. It should be noted that the scheduling of games is an ongoing process, and as such, it is understood by both parties that games will be added as the season progresses, however, the intent of the Central Scheduler is to produce a listing of the games that are scheduled as of November 15, 2008 to each Member. It is anticipated that this list of games will comprise 80% of all games to be played for each of the Members teams, both league games and non-league games.

- 8. Early Termination of Agreement Although the intent of both parties is to have this Agreement cover the period of July 1, 2008 through June 30, 2009, FYH does reserve the right to cancel and terminate the services offered under this agreement in such case that FACYH does not remit the applicable Scheduling Fees as detailed in this Agreement. Likewise, FACYH reserves the right to cancel this Agreement and terminate its participation in the Central Scheduling if it can show due cause that FYH and its employee serving in the role of Central Scheduler is not adequately performing the services outlined in Section #4 above. In such a case that this Agreement is terminated by either party, any unpaid Scheduling Fees will no longer be due and payable by FACYH; however, no reimbursement of Scheduling Fees paid will be made by FYH.
- 9. Entire Agreement This Agreement, constitutes the entire agreement of the parties with respect to the subject matter hereof, and supersedes all previous proposals, oral or written, and all negotiations, conversations, or discussions heretofore had between the parties related to this Agreement.
