Ice Makers (Al Hintz)

Al informed the FYHA board about a decision by the Metro Sports Foundation to build only the main rink at the UP Center. Al indicated with the tight credit market during the summer that the major investor was unable to offer the financing arrangement as proposed last summer. The plan is to move forward with Phase I of the project and build the main rink followed by the other 4 sheets of ice (as Phase II) in 2009.

The Phase I budget is approximately \$25 million with funding sources as follows:

- \$15 million from a bank consortium in the form of a loan
- \$ 3 million from Ace Brandt
- \$ 2 million from Metro Sports Foundation fund raising
- \$ 1 million from the Fargo Public Schools
- \$ 4 Capital Leases

An important component to the bank financing is IRS approval of Metro Sport's 501(C) 3 status.

The Metro Sports Foundation will be looking for assistance from Youth Hocket to help with promotion and fund raising. Al encouraged youth hockey people to attend Metro Sports Board meetings.

Further Al asked the FYHA to carry it's receivable (Carries Salary) through December 31, 2007.
