- Cash balance is \$59,117.
- YTD ice rental is \$14,099 over last year.
- Scheduling fees are up \$11,775 due to centralized scheduler duties assumed by Craig. These are offset by additional wages.
- When Craig accepted centralized scheduler duties, the board approved an increase of \$4,000 in compensation, but this was not paid. Retro pay was distributed to Craig this month.
- Net income is up \$9,000 over previous year due to building fund from Raiders being paid this year.

# ARENA MANAGER REPORT: Presented a verbal report.

- Final demand letter was sent to Rob Sorenson for \$450 uncollected ice rental fee.
- NDSU still owes \$550 for women's hockey team
- Ice rental for May is \$5000, June is \$16,000, and July is \$12,000.
- Will need to pull out the ice this summer in August and it will be back in by September 17th. Craig will need assistance in painting before ice is replaced. Also, we will probably need to add some sand under the floor.
- Jeff Aikens asked to have the water heater checked. The showers do not have hot water.
- Recommend that the assistant rink manager, Mike, return next year.
- Scheduling meeting will be next week. Discuss fees, which should stay the same.
