AHAI BOARD OF DIRECTORS MEETING January 5, 2004

Treasurers Report

A copy of the year to date P&L Statement was distributed and explained by Bob Mathson and unanimously approved by the board.

Registrars Report

Copies of the Registrars Report were handed out. The total number of Illinois Players, Coaches, and Managers that are registered with USA Hockey is 20,788 and the total number of Illinois registered teams is 1935. Players (6 Girls, 6 High School, 1 High School Backup Goalie, 1 Tier I, 7 Tier II, and 3 Tier II Backup Goalies) who "Petitioned to be added to the AHAI Rosters after 10/15/03 were approved by the AHAI Registrar.

Committee Reports

High School
