Meeting was called to order at 6:58 PM

President's Report:

There has been some discussion regarding the lack of a sound system in Peterson Rink (old arena). Mark Worner has had discussions with an acoustics person and received a proposal for 9 remanufactured speakers and the rewiring of the old arena. The cost of this project would hopefully be split three ways between BYHA, the city and the Figure Skating Club. The board has approved to earmark \$750 from Wild sales proceeds to move forward with this project pending the decision of the city and Figure Skating Club.

Steve Pearson submitted a letter of request to Hanover Athletic Association for possible funding to BYHA. A response was received from Hanover Athletic reminding us of all past issues regarding BYHA and Hanover Athletic. Steve sent a response hoping to open new doors and come up with ideas to get Hanover more involved with the hockey program through possibly sponsoring outdoor games, a scholarship fund, etc. A response has yet to be received.

The association has accumulated a credit from the Minnesota Wild and as a result we will be receiving 16 tickets per game for three games (upper deck). 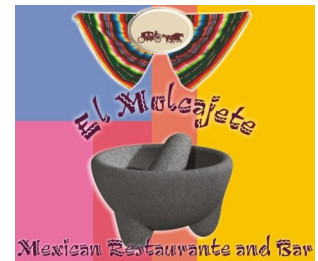
