## Administration - Paul Hahn:

**2008/09 Fees**: July new website platform requires setting fees for coming season now. Ice increasing to \$170/hr at PIC. WYHA fees are always less than costs, but some type of increase necessary to meet increased ice costs. With desire to maintain fairness and equitable increase, proposal to increase fees by twenty dollars per player for all levels with following exception noted due to ice time ratio: Girls Rookie, Boys Rookie and Mini. Additional proposal to increase A Pool tryout fees to \$50 at PeeWee and Bantam levels. Both proposals motioned by Paul H, second by Jim S. Motion carried.

Association mergers: Armstrong/Cooper formalized their merger May '08; Maple Grove/Osseo merging for the 2008-09 trial season at all levels.
