## WYHA Board Meeting Minutes: August 11, 2008

**Present:** All members present excluding Derek Gullett and Brenda Senden.

## Open Forum:

**a. John McGinty, Providence Academy:** Providence requests WYHA allow 13 students from Providence to play together on a Bantam B2 team for upcoming season. Approximately 70% of Providence students and players are from within Wayzata district; remaining from outside hockey associations would seek waiver to play. Level of team would be evaluated on year-to-year basis; Providence uncertain if any currently purchased ice would be turned back for purchase by WYHA. Response requested as soon as possible.

## b. Kelly Fairchild, Erik Jacobs, Darren Nauss, Lance Pitlick, Todd Zejdlik, WYHA Mite Program: Based on the 2008 Mite Survey\* results and our established WYHA goals the following recommendations to further enhance our mite program were presented: Establish "Coaches Committee for Mites" to provide coach support and development (supported by importance of coach as single largest contributor to the success or failure of a season); provide standardized curriculum, practice plans and shared practices for beginning of season; recommend no mite games on PIC A, encourage splitting rink for practice to reduce ice cost; re-evaluate mini mite pricing; maintain tier level structuring with strong coaches for all teams at each level; include school and grade information as part of team formation. Board president requested presenters to provide leadership and coordination of mite program enhancements; board requests VP Mites (John B) to meet with presenters and come back to board with detailed plan once mite registration numbers are known.

\* Mite Survey: 97% of parents indicated their child had a positive experience; 97% indicated their child improved their hockey skills; 97% indicated their child had fun; 93% indicated their child would play again next year; 87% indicated their child played at the right level; 79% indicated the tryout process was fair and objective; 81% indicated the cost to play hockey is reasonable; 93% indicate mite teams should be created by both skill and school.

**Secretary's Report:** Approval of July minutes, Jim S motion, second Rob R, motion carried.

**Administration – Paul Hahn:** Providence Academy request for Bantam team: Jim S motions to approve for one year, Carrie S seconds. Motion denied: 9 votes against, 2 in favor, none abstained.
