# 5. New Business

- a. Items requiring Board approval:
  - i. Volunteer Policy Changes: motion made by Haus and seconded by Appelgren to incorporate the following. Motion passed.
    - 1. Exempt From WHA Volunteer Hours: The following people are exempt from the annual WHA volunteer requirements: Current WHA Board members; Registrar; IP Coaches; Head Coaches; IP Managers 7 Hours credit; Competitive Teams Managers 1 per team; HDC Members (hour credit per hour attended); rostered assistant coaches (competitive level max. 3 per team)\*; Others TBD by WHA Board; \*Coaches must attend at least 80% of practices and games to qualify for the exemption; \*Coaches must be rostered and carry a valid Coaching Card; Coaches and Board members are also exempt from team duties.
    - 2. Volunteer Buyout Options:

      If a family would rather not perform their WHA level requirements, they may opt to choose the Volunteer Option

and instead pay a fee within one week after teams have been selected. If you choose the Buyout Option, your manager is to receive the buyout check for the WHA-Level Functions. If you have more than one player, the oldest players' manager will receive the WHA Buyout Check. The Buyout checks will be cashed as soon as they are received. If you choose the Buyout Option, your family is still required to perform team-level duties. WHA Buyout Option relieves your family of the WHA-Level Functions.

ii. Parent Code of Conduct Violation: motion made by Haus and seconded by LaDouceur to further investigate an incident as documented by the HDC. Motion passed.

### 6. Other Items Discussed:

- a. Fundraising-Schroeder
  - i. Update on ice out: The Ice Out Event is moving forward at a feverish pace!!
