Finance report

- · General update
 - -January expenses were reviewed.
 - -2 more teams need to pay their fees for dome ball.
 - -Web site fee is due.
 - -Rental fees for dome use are also coming due.
 - -Mike C is looking into a laptop owned by PWYSA which would contain scheduling software, financials etc.
 - -\$954 spent on helmets, face masks, hats, bats, gloves, screens and balls when Varsity Sports moved locations and marked everything 75% off.
 - -Income is starting to come in from registrations.
 - -Operations and cash on hand is in good shape going into spring. Building some reserve will allow for field improvements and other equipment needs.

Motion was made to accept the financials. It was seconded and Motion passed.

 - -Timelines reviewed for tryouts

Pitching and catching: Tues., Feb 22.

Main tryout: Sat., Feb 26.

Make up tryout for both: Tues., Mar 1.

- -Even split between main tryout date and make up due to basketball being in Rochester and a couple of hockey tournaments going on.
- -Evaluators are close to being all lined up. Format for all levels is determined. Six + evaluators are scheduled and needed for all days.
- -Board members should plan on being on hand to help where needed.
- -Early bird discount until Feb 10 to receive \$25 dollars off registration fee.
- -Deadline for travel set at Feb 21. "No exceptions".
