# Meeting Minutes September 7, 2011

Meeting called to order by President Tim Hanson at 7:02 p.m.

### **New Rules**

During the next two months I will be attending the association board meetings to discuss any concerns regarding the new rules for the 2011/2012 season. I will also be attending the District 5 Coaches meeting on November 9<sup>th</sup>. I hope we will have some good discussions and will all leave the meetings with a better understanding of how all the new rules will be implemented on the ice. I believe most board meeting are open to all parents so I would hope we have good attendance so I can answer any parent questions prior to the season.

#### Level One on Clinic

This will be the fifth season District 5 has hosted the level 1 clinic. This clinic is in addition to the USA Hockey requirements to be an official. It helps the first year official to learn some basic skills in a controlled environment. Rick Nelson will be overseeing the clinics again this season. Our feedback from last season was that the officials didn't have enough time on the ice, we will double the amount of ice time each new official refereeing at this year's clinic. Once again we will hold two clinics on one day. The clinics will be held on December 4<sup>th</sup> starting at Paynesville at 9:30 am, the second clinic that day will be at Buffalo beginning at 4:00 pm. All first year level 1 officials will be invited to these clinics.
