#### **OLD BUSINESS**

## Stacy Sports Complex Update

We are working through financing issues as the project is in a hold status. Steve is looking for detailed finance documents that John Tredau is working to get to him. North Branch donated money to the City of Stacy to put towards the arena project as we cannot hold onto this money as a non-profit organization. Steel has been ordered for the project. Boards and block have also been ordered.

We may just try and pour a border for the boards and then just flood the rink this year. We are looking to get the shell up for the front of the arena. We are looking for others to help with the dirt work at the new arena site. The website does have updated information from a couple of weeks ago. There are also progress pictures posted online.

First Bank in Wyoming may be willing to help with our financing. Craig is also looking to other organizations for additional financing.

#### **NEW BUSINESS**

- Mike Deschneau (High School Hockey Coach) Started coaching hockey at the High School level. Participated as the assistant men's' hockey coach for several years. Would like to help grow a hockey program close to home. Would like to get the high school players involved at the youth level. Look at possibly assigning a couple of high school kids per team. Mike is also teaching special education at the North Branch Area Public Schools. Would like to possibly get some of the players to come out to our Learn to Skate sessions or mite practices can really help the youth program. Ray would like to try to have 1 meeting per month with all the coaches and would like to get Mike included in these meetings. Looking to create some hockey clinics in the early fall before the season begins.
- A-Frames Can we possibly ask the Shop Class students to create these a-frames? Tom
  will look at creating these frames for the signs created by Nick Miller. Lisa will work to get
  Tom some more information or provide templates for these a-frames
- Mike will see if there are some students available to work on the arena.
- Mandatory Meeting Option New skaters' parents should be required to attend a meeting talking about try-outs and the requirements. This would help provide a better understanding of the process of the pre-skates and try-outs. This would need to take place before the pre-skates to give them a good understanding of the process.
- Goalies We have no goalies trying out at the PeeWee level. There is currently only one player trying out as goalie at the Squirt level. We will either have 0 or 2 goalies for the tryouts. The Goalies are labeled 1 or 2 from the judges' perspective.
- We need to know who will not be participating in the try-outs as this needs to be documented ahead of time. The only excused time is a medical emergency.
- Flagrant Penalty There are 4 scorers and this penalty will average out. PeeWees were told that there is no checking at this level. Evaluators will need to be reminded that there will be no checking during the try-out.
- Identified potential head coaches for the 2<sup>nd</sup> level teams. There have been some identified and will be discussed at the board meeting following the try-outs.
- Request to disburse gambling funds to the City of Stacy for the arena fund was presented. Discussion to follow in October's membership meeting. A quorum is needed.
