OLD BUSINESS

Stacy Sports Complex and Grant Update

There is one large \$30,000 bill from Ron Aho from the steel for the Stacy Arena that is still outstanding. We will look at getting a line of credit to pay the reaming outstanding bills for the Stacy Sports Complex. We have gone out to banks and asked for a mortgage. However, the City owns the land and there is no collateral for taking out loans. We are going to present some options to the City to look at other options for acquiring a loan. The remaining steel is to be completed by the end of 2011.

The Pro Forma is still needed to get the accurate numbers to complete our Grant packet requests.

Request to Disburse Funds

Request to disburse gambling funds to the City of Stacy for the arena fund was presented at the November membership meeting. There is a motion to disburse \$10,000 from the gambling account to the City of Stacy from the sale of cash calendars made by Tom Garin, seconded by Scott Hannah. Motion carried.

Arena committee is looking for a line of credit to pay the remaining outstanding bills from the arena project. Our accountant has highly recommended disbursing funds several times a year.

ByLaw Change

The Bylaw change would remove the need for a membership quorum to conduct charitable gambling approvals. Motion to approve made by Lisa Isaacson, seconded by Tom Garin. No changes to reporting at meetings. As a non-profit all of our information from a gambling account is open to all members. Motion carried.

NEW BUSINESS

There are three (3) more Youth Recreation Night dates where we need 3 volunteers for each night to fill the positions at the concession area. A background check is needed to participate as a volunteer for this school event. All these events take place on a Friday night from 6-9pm. The remaining dates include January 20th, January 27th, and February 17th.
