15 Present

- 1) Call to order-Mark 7:07 pm
- 2) Rink Manager's Report
 - a) Pete's position has been restructured into 2 positions. Joel Marshall has been hired as the Interim Executive director for 6 months and Bryan Pelleterri has been hired as Rink Manager. Both will be re-evaluated after the 6 month interim period. Both positions will work together.
 - b) Nest Fest \$28,000 raised. Glass will get replaced. Nets also need replaced.

3) Ice Inc. Report

a) Joe Taylor has resigned his position from Ice Inc. They need a Board Member to replace his position. Next meeting is September 26, 2011. Motion by Terri that Courtney Corning is the new SWE Rep. 2nd Roxanne. Unanimous.

- ii. Concessions
 - (1) Needs updated contact info for Pepsi to get new refrigerator. Popcorn machine needs to be brought back.

iii. Coaches

- (1) Evaluations
 - (a) ALD's will be on the bench during scrimmaging.
 - (b) Will not be sorting teams prior to 3 on 3.
 - (c) Coaches on ice with kids will be age appropriate and not participating in same level evaluations.
 - (d) Bantam process will be shortened. Will have a decision before high school tryouts.
- (2) CEP Coaches Certification out on web now, costs will be identical, but recertification process has made changes. We will probably only see a 25% increase this year. Note: Level 4 is a \$255 fee and a 16 hour course.
- (3) 2 players requested to try out at Squirt level that are RW&B age.
- (4) Coaches Committee would like a written explanation why Board did not follow their recommendation regarding RW&B and 2003 birth year players.
