Requirements For Figure Skating

Objectives

1. To offer high school club activity status to figure skaters.
2. To recognize the accomplishment, time commitment and athleticism of figure skaters with a letter award to those who meet the requirements.

Qualifications and Letter Requirements

1. The figure skater must be a current student of Roseville Area High School enrolled in grades 7-12. They must also be a current home club member of the Roseville Figure Skating Club (RFSC) and a member of the United States Figure Skating Association (USFS). The figure skater is responsible for all requirements of this criteria and for submitting all required documentation.
2. For the purposes of this program, the skating season will follow RFSC's membership year which begins on July 1 and ends on June 30.
3. Figure skating must be performed at a High School Varsity level or higher as follows:
 - a. The figure skater must skate a minimum of 150 hours during the skating season.
 - b. Hours are to be counted as follows:
 - i. 1 hour = 1 hour
 - ii. At least 75 hours must be skated on contracted RFSC club ice which may include RFSC ice coupons. Only those hours actually skated will count. Absences from a contracted session and unused coupons will not be included in these hours. The remaining hours may be comprised of the following:
 1. Actual hours skated during Roseville ISI class lessons.
 2. Actual hours skated on other RFSC ice under the supervision of the skater's primary coach or a secondary coach approved by the primary coach.
 3. Ice show dress rehearsals will count towards ice time and will equal the number of hours you are required to be at the rink (i.e. first half of the show 1.5 hours = 1.5 hours)
 4. USFSA or ISI competitions will count as 1 hour per event you competed.
 5. Practice ice purchased for a USFSA or ISI competition will also count as total ice time where minutes purchased = minutes skated.
 - c. The figure skater must have passed the ISI Freestyle 6 and/or the USFS Intermediate Free Skate test.

- d. The figure skater must attempt at least one USFS or ISI official test per skating season, with the exception of a skater who has passed their Senior Moves in the Field and/or Freeskating tests.
- e. The figure skater must participate in at least 3 "public" events per skating season, such as competitions, ice shows and exhibitions. At least one of these events must be a USFSA or ISI competition.
 - i. All Ice Show performances will count as 1 public event/year. (Three performances do not equal 3 public events.)
 - ii. Competitions will count as 1 public event, no matter the number of events entered.
- 4. The figure skater must follow the Minnesota State High School League rules of eligibility and conduct.
- 5. The figure skater must train under the supervision of an approved RFSC professional coach. Only the skater's primary private coach will be considered as the coach supervising the skater's training.
- 6. The figure skater needs to submit the necessary documentation to a member of the RFSC Lettering Program Committee for verification which must include total hours skated, ordinal sheets from competitions, forms from tests attempted or completed, etc. A Requirements Form is available on the RFSC website. This form must be submitted before the end of the current membership year, June 30.

Once a figure skater has attained letter status, a bar can be earned for each subsequent year if the skater has fulfilled all of the above requirements for that season until a skater graduates.

The Roseville Figure Skating Club operates as an independent provider for ISD #623 and is administered by the RFSC Board of Directors. The RFSC is a full member of the USFSA and operates under the auspices of it.
