This signature page must be signed and turned in to the Lettering, Roseville Figure Skating Club, (RFSC) contact for the current skating season.

- 1. Eligibility – I understand that I must meet all the eligibility requirements set forth for the Roseville Area Schools Lettering Program. I understand that if I fail to meet any of the eligibility requirements, including but not limited to my failure to adhere to all school district rules, policies and requirements concerning student activities including, but not limited to attendance, conduct, scholastic standing and other eligibility requirements as required of all Roseville Area Schools athletes, that I forfeit my eligibility to earn a varsity letter-even if I have met all other criteria.**
- 2. Costs – I understand that I am responsible for all costs associated with the Roseville Area Schools Lettering Program including, but not limited to membership fees, coaches fees, and costs of physical examinations.**
- 3. Coaching/Training – I understand that I must train under the supervision of an approved RFSC Professional Coach.**
- 4. Lettering Requirements – I understand that in addition to the Eligibility Requirements, I must meet all of the following criteria to earn a varsity letter for the current skating season:**
 - a. I must be a current student at a Roseville Area School enrolled in grades 7-12 and a Home Club Member of RFSC;**
 - b. I must skate a minimum of 150 hours during the skating season at either the Roseville Skating Center or any other affiliated USFS clubs.**
 - c. I must have passed the ISI Freestyle 6 or USFS Intermediate Free Skate test.**
 - d. I must attempt at least one USFS or ISI official test per skating season.**
 - e. I must participate in at least three (3) public events per skating season such as competitions, ice shows and exhibitions. ¹ At least one of the events must be a USFS or ISI competition.**
 - f. I must turn in all necessary documentation to prove my participation in public events [ordinal sheets from competitions, copies of testing**

¹ All Ice Show performances will count as 1 public event/year. (three performances do not equal 3 public events). Competitions will count as 1 public event, no matter the number of events entered.

forms, ice show or exhibition programs listing my name as a participant].

I have read the requirements in the Roseville Area Schools Lettering Skater-Parent Agreement for this skating season. I understand that I must meet all of these requirements to earn a varsity letter and subsequent lettering bars and will abide by these rules and requirements. I also understand that the consequences in the event of my failure to meet all said requirements is ineligibility to receive a varsity letter for this skating season.
