# **Secretary Report:** Trish Dahl –

# **Treasurer Report:** Greg Winter -

Savings: \$5312.16Checking: \$72,730.72

• Long-range account \$58,567.63

• Tournament revenue \$24,761.87

- Tournament expenses \$11,220.10 (trophies, golf cart, dumpster, concessions not included)
- Expecting to make about \$8000 profit
- Motion made to compensate Scott Rice for field prep work (\$500 gift card)
- Motion made to compensate Greg Winter son-in-law for helping with tax forms (\$75 card for him?)
- Julio and Greg to meet offline to discuss who gets paid what
- Greg asked for help with the 990s tax form

#### **Registrars Report:** Andrea Cegielski –

- Motion made to keep registration rates the same for fall season and review for spring season
- Motion passes.
- Thorough analysis of where our money is going is requested.
- Discussion about moving all registration to be done online. Less than 3% of our registrations this past season were done by mail in. Credit card fees are built into our fee.
- "Walk in" registration will be made available (6/19 and 6/25 at the District Ed Ctr) so that those families who don't have internet access can come in and we will register them online at the walk in. At this same time, samples of the new uniforms will be made available for families to see sizing which will facilitate ordering. Mailers will be sent to all families to let them know about this opportunity, as well as posting it on the website.
- Motion made to increase late fees for inhouse program to be \$30 (and \$30 for drop); traveling program to be \$50 (\$50 for drop) beginning this fall; motion passes
- Discussion of scholarship policy tabled to June meeting

#### **Tournament Directors Report:**

Discussion was had about success of our home tournament. Generally speaking we will
make a profit but less revenue than in years past. Consensus that more promotion needs
to be done for future tournaments, including having information available at the MYSA
Winter Symposium and the East District packet meeting. Should pursue other clubs with
offers of discounts to help fill brackets as time draws closer for the tournament.
