- AGM Follow Up Constitution changes
- Amy and Ernie have found some discrepancies in the constitutional changes that were to occur and have brought this to the attention of Robert who will see to it that the corrections are made.
- Implementation of Background Check Policy –
- Robert researched the background check policy used by Kelsey School Division and Shawn spoke on this as he was a trustee at the time that helped to develop this policy.
- There were some concerns raised in regards to the background check that perhaps some of the proposed five-year restrictions may conflict with judicial system penalties for similar crimes. As well, concern was raised that some of these restrictions may conflict with certain human rights.

Motion made by Karl Steppan that The Pas Minor Hockey Association adopts a lifetime ban for all individuals with any convictions pertaining to:

- Any type of sexual assault
- Invitation to sexual touching
- Procuring sexual activity
- Indictable criminal offences for youth abuse
- Any Court Order forbidding the individual to have contact with children under the age of 14

Motion made by Shawn Hnidy that the criminal record checks be done at the time of registration and that they be considered satisfactory for that individual's duration of their continuous volunteer time with The Pas Minor Hockey Association. In the event that the individual ends their position with The Pas Minor Hockey Association and then returns, criminal checks will need to be re-done.

- Online Registration, Website
 - Looking into the possibility of online registration
- Some options for online registration are to utilize the Hockey Canada website, much the same way as clinic registrations; or to use a separate company, a web-hosting platform, to allow individuals to register and pay online
- The separate company being considered has an initial set-up, design and training fee of \$995 discounted to \$795 for this website
 - \$65/ month maintenance fee reduced down to \$53/month, which may be offset by allowing businesses to utilize the site for business advertising
 - Purpose of online registration is to reduce the workload for The Pas Minor Hockey Association, especially the registrar, as the current website is not user friendly. As well, each team/league could be given access to a specific area of the database and input any information they would like pertaining to their specific group. Website calendars can be linked to home computer calendars as well, such as Outlook. Website is mobile friendly and would become the main source of information for TPMHA.
 - There would be a \$3.75 transaction fee for paying by credit card, PayPal, etc. each time you make a payment online, no fee for making payments directly to TPMHA
