- a. District Scott Dornfeld—D3 Director—here to talk about penalty rule resulting by Jack Jabolinski incident. District Directors are working on putting together a guideline. iv. Girls Program

- 1. The 2012-2013 OMGHA girls program will have (9) teams. This count will put us in the top five largest associations in the state. I expect the states U14B program will once again have less than (15) teams total. I believe a U14B metro league (like last year) will once again work.
- 2. EAH will be running in-season skill development for all OMGHA girls' teams twice a month. These months include November, December, January and February. EAH will be running U10 Development Camp, U12 and U14 Pre-Tryout Camps. Required dry-land will be placed on all teams schedule 1-2 times per month.
- **3.** Some changes for the Girls program for the up coming season include: 1) Parent Head Coaches will be first choice for all teams except U14A. 2) Parent Head Coaches will be announced after tryouts are completed and their daughters have be properly place on a team. 2) Traditional tryout system for U12 and U14, no additional charge to tryout for U12 and U14.
- 4. Goalie incentive programs for U10, U12 and U14 are being considered. Goalie guidelines for U10, U12 and U14 are being established for teams that may find themselves without a full time goalie. The goalie position for both boys and girls traveling still seem to be a position that is a challenge to fill. Goalie start-ups for both boys and girls traveling are low. OMGHA is putting considerable resources into recruitment and retention at the goalie position for the 2012-2013 seasons. Goalie training will be through ProHybrid
