## Team Formation policy

Discussion: Ensuring fairness when splitting into two teams at any grade level. It seems that the fairest way is a blind draft. (Done this past fall for the $4{ }^{\text {th }}$ grade team) Blind draft necessary, and honesty of adults that know the kids and are evaluating the kids.
Discussion regarding team size and the need for bigger teams as the kids get older, specialization is critical and teams need larger rosters to compete. What works at $2^{\text {nd }}$ grade won't work for $7^{\text {th }}$ grade.
