# **Secretary Report:** Trish Dahl –

#### Treasurer Report: Megan Schmidt

- All invoices need to be reconciled by Julio or Trish before submitting to Megan
- Two teams going to fall State Tournament, checks for reimbursement to be issued before their departure
- Nine teams went to fall jamboree & need reimbursement
- Coaches are due their second half payment for fall season
- MYSA now paid in full
- Edward Jones credit card account now closed; have no current credit card for the association; will discuss getting a new one
- Working on a needs assessment do we need a credit card? Do we need a Sam's Club card? What makes the most sense for us right now?
- Ken McCarthy a possibility for needs assessment (or he may know of someone)
- Jay Breidinger has agreed (at no cost) to help us frame things up for the next treasurer: filing, tax returns, etc.
- QuickBooks is in good shape
- Brian Wrabitz will be here in December and will be able to help out as well

Discussion held on concerns raised about traveling boys teams performance & why it seems to drop off after teams switch to traveling. Point raised about perhaps moving some U10 teams to maroon to help prepare them for the changes at U11. MYSA's rule about allowing players to transfer to any team in any community ultimately hurts us in the long run.

### Director of In House Age Group Coordinators: Deb Kipp

- Fields were the biggest issue for fall season; communication with families also an issue
- Andrea suggested centralizing team formation for U5 U8, possibly with Deb taking charge of this
- Protocol needs to be provided to each age coordinator
- Temporary signage on the fields would be beneficial also, perhaps using zip ties to attach signs to the nets themselves
- Jason noted that the 5 v 5 formation (goalie in net) a good formation and allowed more touches on the ball for players on the field

#### **Director of Coaching Report:** Kevin Kielsa –

- Groups that do well typically have a champion parent in the age group
- Summer boys soccer camp now scheduled for the 2<sup>nd</sup> week of summer vacation for mornings (June 17<sup>th</sup> June 21<sup>st</sup>)
- Special activities, equipment, etc. for the camp need to be worked out ahead of time
- Coaching evaluations have been sent in for summer season
- For Micro and Inhouse coaches, their info not always available; possible not all emails received to evaluate inhouse coaches
- Generally good feedback on traveling coaches but some negative. Negative feedback has been forwarded to the coach if deemed beneficial to them
- High school boys were a good help to teams and will try to do more with them in the future
- Player evaluations (Zoom reports) for fall season sent out (1<sup>st</sup> time used in fall)
- Asked if somehow an evaluation could be done of inhouse players

#### Field Director: Scott Rice -

- Painting issues to be addressed at another time
- Attended Athletic Council mtg; told us no to all of our proposals. Said too many unknowns at this time
- Possible Field 8 will be designated for lacrosse (lacrosse has asked for 8, 9 and 10), may be a conflict with soccer in the future
- Field half the size of Field 8 being built on the new site, intended for all inhouse program to use at one time
- Watering a problem; overwatering of high school fields, a broken pipe found, gophers a problem as well on Field 6
- Considering moving all maintenance to be done by the high school for a fee; service agreement would be needed in this case
- Need to let Hanifl know about painting we could offer to set lines for them

#### **NEW BUSINESS**

### **Winter Training**

- November April is our off season; if we have training be free & open to players, would be difficult to predict attendance
- Proposing 3 sessions this winter (Nov/Dec.; Jan/Feb; March/April)
- Kevin sent out an email to coaches & ACs to ask families which session(s) they think they could attend; nearly all said March & April, about 2/3 for Jan & Feb. Specifically:
  - U14 girls said all 3 sessions
  - U13 boys said all 3
  - U11 girls said all 3
  - U9 boys said all 3
  - U10 girls said all 3
- Suggested we use a "kit" with Mahtomedi logo, priced at \$30
- Julio recommended a fee for training for ownership
- Kevin suggested fee to cover kit plus some hourly coverage
- Megan stated that U12 coach suggested "clinics", like the goalkeeper clinic
- Julio reiterated the importance of free play; perhaps have open blocks of time for that in Nov/Dec. session?
- Schedule will be Mondays 6 7 pm girls (U9 U13) structured free play and 7 8 pm girls (U9 U12) skill training; to use field 1 (closest to entry); Tuesdays 7 8 pm boys (U9 U13) structured free play and 8 9 pm U13 & U14 boys & girls skill training
- Motion made to not charge any fee but require each player to purchase the kit in order to participate & make kit \$20; shirts will be the ticket in
