This contract, and amendments and supplements thereto, is between the Oakdale Athletic Association, (hereinafter OAA) and _____ (hereinafter UMPIRE), an independent contractor, not an employee of OAA, address _____, witnesseth that:

The OAA, pursuant to its bylaws, is empowered to enter into contracts necessary for the performance of duties in the accomplishment of the organizations purpose to teach the fundamentals of athletics to members of the OAA, and to develop characteristics of good sportsmanship and cooperation within each participant, and

WHEREAS, this contract contemplates that the UMPIRE will provide certain services on behalf of OAA and will be paid for those services as specified, and

WHEREAS, the UMPIRE represents that he or she duly qualified and willing to perform the services set forth herein,

NOW, THEREFORE, it is agreed:

I. UMPIRE DUTIES

- A. Be familiar with the League Rules and apply them to the best of your ability.
- B. Act as umpire for scheduled league games as determined by the League Director.
- C. Turn in a signed scorecard as proof of completion of a game to qualify for compensation.

II. PAYMENT OF SERVICES

- A. Compensation: \$_____/game
- B. The game shall consist of completion of normally scheduled competition between two teams as described in League Rules. Forfeits by either or both teams is considered completion of a game. Weather related cancellation of scheduled competition is not completion of a game until rescheduled.
- C. The total obligation of the OAA will not exceed compensation for the actual number of games completed as determined by a signed scorecard.

III. TERM OF CONTRACT. This contract shall be begin on _____ or the start of the season, and shall remain in effect until _____, or until the completion of the season, whichever occurs last.

IV. CANCELLATION. This contract may be canceled by the OAA or UMPIRE at any time, with or without cause upon written notice to the other party. In the event of such a cancellation, the CONTRACTEE shall be entitled to payment, determined on a pro rata basis, for work or services satisfactorily performed.

V. LIABILITY. Each party agrees that it will be responsible for its own actions and the results thereof to the extent authorized by law and shall not be responsible for the acts of the other party and the results thereof.

VI. AUDITS. The books, records, documents, and accounting procedures and practices of the UMPIRE relevant to this contract shall be subject to examination by OAA or any independent auditor designed by the OAA, or for tax purposes by federal or state governments. Funds that must be repaid to the federal or state government as a result of adverse audit findings attributable to the UMPIRE must be repaid by the UMPIRE and not by OAA.

- VII. TAX PROVISION. Execution of this contract may result in action to require the UMPIRE to file federal and state tax returns. In accordance with federal and state tax laws OAA shall provide the UMPIRE with a notice of nonemployee compensation. Failure to receive a notice does not discharge the obligations of the UMPIRE to file federal or state tax returns.
