President's Report

The executive committee proposed for discussion a plan to restructure the WHA board composition and realign several positions to non-voting volunteer assignments/opportunities. Drivers for this initiative include reducing the number of board positions that need to be filled on a bi-annual basis (individuals voted onto the board serve two year terms), meeting efficiency, and creating more options for members to contribute and complete their volunteer hours through expanded opportunities.

At the conclusion of the discussion of potential advantages and drawbacks to realignment of several different positions, Dondelinger motioned to realign the WHA Board by converting three positions to non-voting volunteer opportunities and eliminating one position altogether per the following:
