• Reviewed/approved June Minutes – Carmen J made a motion to approve, Scott second, all in favor.

#### **Old Business:**

- Bantam A tournament Working on seeing if we will get any interest to host a Bantam A tournament at Centennial
- Hardship letter reviewed and ready for final approval

## New Business / Agenda:

- FUND-U fundraising Rick Jackson and Chad Nicholls review territory for fundraising.
  - Want to work with an association with product, service and needs of an organization. Would like to be a 1 stop solution for fundraising on a team, individual and association level.
  - o Would like to be the primary fundraising contact for an association.
  - Scott made motion to have Pastry Puffins at Registration and at Managers meeting but and not utilize Butter Braid at CYHA this year. Carmen second motion carried.
- Recap Puck Bangers Ball golf event summary presented by Rick Jackson. Net Revenue \$10,739 for goalie program. 3 year high for participation however the success of the event was soured by the conduct / behavior of many participants including disregard of rules, excess alcohol consumption and inappropriate conduct to the staff. Need to develop plans to improve this next year if we would like to host another event next year.
- Registration update/Open Houses (online registration is NOW open)
  - 3 large metal signs and some others out but 5 more to be placed.
  - Volunteers for registration if fine
  - There is a total of \$33,000 of open payments due to CYHA from 53 families. No family with open balance will be allowed to register / Tryout for CYHA in the 2012-2013 season.
- Updates from July D10 Presidents meeting.
  - No voting on A / AA plans
  - o D10 have \$5K available for funding programs
  - o Need to have 1 EMT for every 2 sheets of ice.
  - o D10 has audit resource available
  - o Tim Timm needs Bantam AA coach contact information ASAP
  - o Regions are going to be more local
  - o There are a couple of associations that want to move back into D10
