- \$500 to hold and maintain license plus \$200 per site. No mileage or other wages collected. Calling of Bingo or filling in for the absence of an employee falls under (No extra compensation) job responsibilities.
- Mileage can be paid for attending any required continuing education classes.

## Site Manager

- \$130 per site with no mileage. Mileage would be paid for attending required continuing education classes that this position may need (currently not required for this position).

## **Auditor**

- \$8 a box at all sites and no mileage.

## **Depositor**

\$30 per pay period and no mileage

## **Month End Inventory Recorder**

- \$20 per site and no mileage

## **Bingo Callers/Sellers**

- Short Game (9 games or less) \$30, Long Game (10 games or more) \$40
