*Treasurer's Report*: Accepted (M#2/S/P) Clinic expenses vs. income: Wendy will let the Board know why the difference.

Update on sport court purchase: RMR has received \$20,000 for the sport court and has credited the Colo Performance AR account to reflect a zero balance. Colorado Performance was written a check in the amount of \$2,000.00 for their portion.

## Committee Reports:

❖ Office Committee Fariba Samimi, a past parent, donated a copier to the RMR with an estimated value of \$4,000. Xerox WorkCentre 7328 color laser network copier/printer/scanner. Wendy will look into finding a maintenance plan.

#### Referee:

# **Events Committee**

#### Old Business:

#### New Business:

- Current membership to date is 5,347. Total membership in the previous season was 5,990. 89% of the previous season's membership.
- South Metro Volleyball and Tracy Dudley are providing opportunities for people to play volleyball with the following:

No age restriction No rules-limited

Claims to be the largest volleyball organization in Colorado

Glenn suggested the RMR hire a publicist to write an article for the RMR website to state what the RMR can provide to it's membership. This would be good advertising for us. The Board declined. No vote was taken.

• IRC complaint and penalty assessed to COVOCO. A Junior committee was formed to review the situation. Some memberships were put on hold for fees and non-conformance. One member appealed was not responsible for the Covoco debt and their membership will be reinstated.

### Findings for other member:

- 1. 3 year membership suspension for not providing documentation for on-hold policy
- 2. This member violated her previous probation.
- 3. This member still needs to pay her fees.
- 4. This member cannot hold a membership position in the RMR organization.

Motion: RMR Board confirms the findings of the Junior IRC Committee. This member must pay dues to become a member after their 3 years of suspension. (M/S/#3).
