### 5. New Business

- a. Girl's Traveling Committee Business, submitted by Mark Johnson
  - i. Team formation for girls U14—expected 3 U14 teams...last month 1 A up and 2 lower blended was how the Board voted—this received much feedback. In response the Girls Traveling committee did a survey and received a lot of feedback which we have a few parents here to share viewpoints—first is Mike Dahlquist---he appreciated the opportunity to speak, and the fact that the Traveling Committee put out the survey to ask for the parent's opinion. U14 is a challenging level—we lose some kids to HS hockey, OMGHA has the luxury of having 3 teams—unlike many associations. Mr. Dahlquist feels we need suggestions from MN/USA hockey—maybe they should dictate which associations need to field a B team. Last year only 9 B teams in the state. Mr. Dahlquist feels there should be an Upper A, Lower, A and a B team...create 3 ranked team and opportunities for all level skates within the U14. Makes it easier to tailor a practice game plan and game strategy for like skaters. Skill can be significantly different when you have a team with several different levels of skaters. Mr. Dahlquist thinks that 3 ranked teams is the best approach—even if it is Upper A, Middle A and Lower A—if OMGHA wants to get rid of the B program. Mr. Dahlquist mentioned that his daughter wanted to be at the meeting, because she does not want to see the balanced teams and many of her teammates

- feel the same way. This is not a knock the skills of the players—it allows development to be more in line with the skills of the player and promotes more room to grow for all skaters. Goal is to promote hockey—and the model being proposed could make it frustrating for the players. Need to put the girls in a position to succeed. Again. Mr. Dahlquist appreciated the fact that Board and Traveling Committee allowed the survey and for the opportunity to speak at the Board meeting. Comment by Mr. Ralph---his only concern is what about what happens if other programs balance and they girls don't succeed…are we preventing others. Question by Mr. Kunz about process that will take place—if Traveling Girls Committee proposes a new team structure, it will need to be re-voted upon. Mr. Kunz also commented that the Traveling Committee should think about what happens if the girls who do not make the upper team; will we allow them to try out for the high school team and come back to the same team they made during try-outs?
- Second parent to speak—Eric Pain—he also thanked the Board for the opportunity to speak. He has spoken to several parents over the last few day and players. The players he has spoken to feel they would like the balance program—they want to be challenged. Keep it the same as it has been since they were U10's. Last year it was a 5-1 ratio of A teams to B teams---thus we know that several of the A team in the state should be competing at the B level. Mr. Pain feels that in order to keep it competitive the lower 2 teams need to be balance. Mr. Pain asked his daughter what she wanted—and she wants to be challenged. She also asked the parents to get out of the way and let them play hockey. Mr. Smith asked about the decision by MN Hockey to allow A and B teams to play each other, Mr. Pain believes that MN hockey needs to make the decision, but because they are not, each association needs to make the decision that is best for their association. Follow up question by Mr. Smith about the ratios—Mr. Pain...ratio 5-1 U14 state ratio at the U14 level—pulled off MN Hockey website. Confirmation that Mr. Pain is in favor of 1 upper team and 2 balanced team. Last year OMGHA had 1 upper A, 1 lower A and one B team. Differing opinions as to if this was successful. Hard because only 9 B teams in the state so lots of travel and playing same team over and over. With change this year, the A teams can play the B teams---but not in tournaments. Possible that some A teams might not want to play a B team—could be a struggle. Mr. Dahl mentioned that only 5 other associations in the state rosters more than 2 teams. Many only roster A teams.
- iii. D3—would like to know tonight about the structure of our U14 program---Mr. Smith mentioned again that MN hockey would like to them to vote now. Girls Traveling Committee will discuss the conversation tonight, and thanked both parents for their time and willingness to speak.

## b. House Jerseys-

i. House Committee and Marketing Committee have both recommended suggestions for the placements of the logos on the house jerseys. Marketing would like business logo on the front and OMGHA on the shoulder—option 1. House Committee would like OMGHA logo on the front and business logo on the back. –option 2. Mr. Appelman—spoke on behalf of having the logo on the front—it is a way to partner with the community and was able to raise more money by having the logo on the front of the jersey. Mr. Appelman stated that is hard to market the house program with its limited exposure to those outside the program. Question—by Mr. Helvey—as to how much the jersey's cost---rough estimate provided by Mr. Carlson and Mr. Appelman--\$8.00 for single color and \$16.50 double colored jersey's...without screening of logo's on the side. Mr. Janicke spoke on behalf of the House committee...not a huge ground swell of support for the business logos on the front. Having these logos on the jersey's—doesn't really have a lot of marketing pull as the kids play the same 6 teams.—could instead package the jersey with directory and other opportunity. Matt Margenau pointed out the marketing opportunity of kids wearing their OMGHA jersey's around town. Mr. Brandt mentioned that the U8 teams do travel and we were the only association without logo front and center. Much other discussion ensued. Mr. Borsch---brought up that marketing and branding are two different things. Mr. Appelman did a

fantastic job of marketing this year—better than ever before. Cost for jersey's and socks for upper level was \$12,000 and that \$3,000 for lower level...Mr. Smith reminded the voting members that they are voting for either option one or option two...vote is purely for placement of logo.

Votes for option 1—2 Votes for option 2—14—option 2 carries
