## Pagel:

Greg Clough indicated that the ice is currently out at Pagel. The four new in-ice logos

(Lexus/Cub/Youngstedts/Maynard's) will be going in on Wednesday; ice returns directly after. This week the Zamboni's annual engine emissions check will be done and submitted to the state.

Greg recommended that we purchase pucks to reduce the glass breakage at Pagel (30 panes broken to date; \$18,000 replacement cost year to date). Pucks would be checkout from the rink attendant for practices/games. Dave Erickson will research sponsorship of sponsor logo pucks for practice and MYHA logo pucks for games.

#### Fundraising:

Bret Johnson received a call from Maynard's. They were concerned that a number of MYHA's discount cards were sold on their deck on expiration date; Bret will research to see who was responsible.

Bret indicated that the annual MYHA Golf outing will not be held this year due to a scheduling conflict.

# **Charitable Gambling:**

In accordance with Minnesota statute Denise would be a non-voting MYHA Board member. Sharon would work as Denise's assistant through the end of the fall to help with the transition. Dave Erickson moved that Denise DeBoer take over as MYHA Gambling Manager effective 07.01.13. Bret Johnson second. Approved on a voice vote.

We also discussed moving funds from the Charitable Gambling Account to the MYHA General Account during the month of June. The amount not to exceed \$10,000.



## Vice President:

Andy asked for assistance in looking at the MYHA website with an eye to improvements in the landing page, minimizing impediments to navigation, and exploring the options for greater social media integration. Brian, Dave, TJ, & Andy will meet in the near future to begin the process.

#### **Registration:**

#### **Equipment:**

Andy provided an overview of outsourcing our Jersey distribution & collection. Gemini is a local company that provides this service, Bauer is another potential provider. For an annual fee per player (\$75 was suggested) the service company provides the jersey, changes Sponsor placard, changes player number. Options include players keeping their jersey, or the company collecting and storing the jerseys for the off season. The Board agreed that it is worth investigating this service. A formal proposal will be presented at the July meeting so if the Board decides to move forward with the new service, the process would be in place prior to the opening of Registration.
