

Minutes of the USA Wrestling - Ohio Annual Meeting September 30, 2007

Determination of quorum: To have a quorum, at least 25% of the Officers, Directors, and At-Large Board Members (i.e., a minimum of nine) must be present along with representatives from at least 10% of the Chartered Clubs (i.e., a minimum of nine). Twenty-four (24) Officers, Directors, and At-Large Board Members were present, and sixteen (16) Chartered Clubs were represented at the beginning of the meeting. Since it was determined that we had a quorum, the meeting was called to order at 10:05 AM.

The Minutes from the 2006 General Meeting were approved as written by acclamation. (**Motion** by Wendel Donathan and **second** by Debbi Kallai).

OFFICERS AND DIRECTORS REPORTS

1. Chairperson's report – Chris Kallai

Chris noted that everyone should keep things moving during their reports. There are a lot of items to cover so get to the point and complete your reports.

Chris thanked all the Tournament Directors, mat officials, pairing officials and Coaches for helping this past year. He also thanked all those that helped in any way at the FILA Cadet/ University tournament and the Central Regional and the coaches/ clinicians for the Fargo teams and the dual teams. Ohio is truly a "hot bed" of wrestling.

In 2008, Ohio will host the Kids/ Cadet/ Junior Regional. We will have it until 2010, when it will move to Kentucky. The Sports Commission support worked very well for both the FILA and the Central Regional.

2. Vice Chairperson's Report – Leo Saniuk

As part of the Vice Chairperson's job, he was in charge of Tournaments. There were 2464 wrestlers at the qualifiers.

The Fargo schedule for 2008 was passed out. Wrestling will start July 19th and end July 26th.

During the 2007-2008 season, Leo will be working on job descriptions for all positions. Leo will email the current job description. Please review it, make modifications, if necessary, and return to Leo.

3. **Treasurer's Report** - John Cvetic

John distributed copies of the financial statement comparing the financial position, income, and expenses for fiscal years 2006 and 2007. Some of the highlights included:

- a. USA Wrestling Ohio made \$12000 in 2007; to offset the \$6000 loss in 2006. This was attributed to a cut back in support costs (coaches clinics, travel, etc.) and card sales (see below).
- b. Card sales brought in and extra \$6200 from the Arnold Classic and the FILA/ University Nationals. Also \$2000 of that was from Ohio wrestlers buying cards at the tournament as opposed to on line.
- c. We did not receive any grass roots funding from USA Wrestling (had budgeted \$1000) and we lost approximately (\$1100) on the Central Regional and Fila. The Cleveland and Columbus Sport Commissions took losses on the actual event.

The Treasurer's report was accepted by acclamation (**Motion** by Bob Vallarelli and **second** by Pete Bolanis).

John Cvetic said that the upcoming year's budget was laid out to increase the support services since we are recommending having a separate Greco and Freestyle Development Director (new business); also he put in an increased loss for the Central Regional since 2008 will also include the Juniors.

Motion by Carol Saniuk and **second** by Debbi Kallai to accept the budget as proposed. **Motion passed** by acclamation.

4. **Registration Chairperson's Report** – John Cvetic for Clara Smith

John reported that our numbers were down slightly in 2007 as follows:

5. Kids / Schoolboy Director's Report – John Sopczak

John thanked his coaching staff for the Schoolboy Duals, which was a very tough tournament. Team had 9 forfeits, but some individuals did very well.

Chris thanked John for stepping in and replacing Doug Howard at the last minute. Great job, especially given the circumstances.

6. Cadet Director's Report - Jeff Kullman

Jeff reported that this year had one of the best groups ever. He gave a lot of the credit to the stability of the staff. He thanked Chris, Leo and John for listening and then doing what needed to be done. Frank Baxter was also a great help to the Cadet team in his new role as Team Leader. No team for the Cadet duals in 2007 and this needs to be done in 2008.

In Fargo, there were 15 Freestyle All Americans: 6 finalists and 4 champions; Greco had 2 All Americans.

Jeff emphasized the importance of our Cadet Teams, since this is the athlete's first real chance to see national competition and the college coaches start looking at the athletes at this time.

7. Junior Director's Report – Frank Baxter for Jerry Nadeau

Frank reported that the Junior National Team did well. In Greco, we had 4 All Americans – 1 champion; and in Freestyle, there were 6 All Americans and 1 champion. The Cadet team runs like a well-oiled machine. Juniors have bright spots – Jon Horn was good with Greco. Coaches worked well together.

8. Open Director's Report – Joel Greenlee

No report.

9. Coaches Director's Report - Chris Kallai for Jim Speelman

Focus for 2008 is to be sure that coaches get to the tournaments/ clinics that they need to attend so they can be upgraded

10 Beach Director's Report – Jeff Bucher

No report. Nothing done this year. This is an area that we must promote as part of USA Wrestling.

11. Wrestling Development Director's Report – Jim Lehman

Jim reported that there were clinics prior to the beginning of wrestling at the qualifiers. They were about 20 minutes in length with a focus on strategy. Jim would like to organize some mini-camps in 2008 prior to Fargo.

12. Folkstyle Director's Report – John Sopczak for Charlie Smith

Support for Folkstyle needs to continue – numbers were down at the State Tournament. We may need more promotion of this. Thanks to the Folkstyle group for all their work.

13. Women's Wrestling Director's Report – Brian Nicola for Jim Martin

Brian stated that the women's wrestling needs more promotion and general knowledge about the sport and the opportunities need to get out to all female wrestlers. Plan is to email all coaches for active recruiting of female wrestlers for the Fargo team. University of Cumberland will get involved and will host the camp. It will be a one week camp for the same cost.

14. Mat Officials Director's Report - Bob Vallarelli

Bob reported that there over 100 mat officials in Ohio. Thirty of whom worked 4 or more tournaments and 67 worked less than 2; 2 did not work any tournaments.

Fargo used "one man mechanics" this year, due to official shortage. One man is a misnomer; it was really "two man" – one official in the center of the mat and one at the table.

There are 9 officials submitted for an upgrade. There is a major concern that our officials are getting older – we need to be training younger officials and need to promote/ encourage younger people to get involved and become officials.

15. Pairing Co-Director's Report - Debbi Kallai

Debbi reported that we have 26 pairers but we still need more. Carol Saniuk is now a P1 and Tina Shindel is a P2. We also have some new P3s.

Debbi reported that the computer program, TRACK WRESTLING, will be used at one of the state tournaments and hopefully one of the qualifiers in 2008.

16. International Exchange Director's Report – Jon Horn

Jon reported that he took a team to Serbia for 17 days. The eleven wrestlers worked out twice a day with the Serbian National Team and had 4 duals.

Jon stated the goals for 2008 were to take 7 wrestlers to Serbia. Jon is planning on staying 4 weeks – wrestlers 2-3 weeks.

In April, 2008, the Serbian team will be coming to April. We will need top level wrestlers for them to work with for the 11 days they will be here. By December Jon will have firm dates for the visit of the Serbians here and for the trip over there. He achieved his cost goal of reducing the \$2700 per wrestler fee to \$1500.

17. Media / Promotions Director's Report - Carol Saniuk

Carol reported that the web site is easy to use. We have 150 members registered for online newsletters. Ad space is available. She has been able to keep the website up-to-date – getting items posted within hours of receipt.

You can click on the calendar to get more information about an event. She has also updated the pairing officials portion to give the guidelines as to how to upgrade.

We will be updating all Officers and Directors on the website with a digital picture, which will also be used on their ID badge.

18. Fund Raising Director's Report – Wendel Donathan

Wendel reported that the Warren County Convention & Visitors Bureau is interested in working with us – they are located in the Mason area. They have bid on the Body Bar Tournament and will donate \$2000 to our organization if we will commit to work it.

It was also discussed to get some corporate sponsors. John cautioned that we cannot accept funds raised for a specific person, but we can for a “general” purpose. There is a letter written to enlist some corporate sponsors. John Cvetic is to get the letter to Wendel.

OLD BUSINESS

1. Job Descriptions for At Large Members

Leo distributed the At Large Board Member job description. Item 3 was added “May be part of the petition committees that pick the Cadet/ Junior teams going

to the Cadet and Junior Nationals if they work at least four (4) Ohio-based USA Wrestling Tournaments.” At Large Members were reminded that they must sign in at the tournaments.

2. Dual Meet Teams

USAWO will pay entry fees for the Dual Meet teams (Schoolboy, Cadet, Junior). The organization cannot take the financial hit. The Junior Team is always up against the Disney Duals. There was a lot of discussion about the “better” competition at the National Team Duals vs. Disney – a majority of the members thing we need a better method of promoting the Duals”.

The Cadet Dual Team is usually not a problem. The location allows for a “cheaper” participation fee and the commitment is better from this age group.

It was discussed whether Ohio could host the Duals. There is a possibility to bring the Cadet and Schoolboy Duals to Ohio (the Juniors will not likely move from Oklahoma). Contracts will be renewed in 2008.

Can we come up with some sponsorship activities to help offset participation fees? A Golf outing was suggested.

Bob Dies suggested that we have 3 Dual Team Directors. These individuals would help to get sponsorships and support for the different Dual Teams, organize and help select the team, set the budget, select the coaches and collect the money.

Proposed Constitution and Bylaws Amendments

The following amendments were proposed, discussed and voted on:

- A proposed amendment to Article 5.2 Directors was proposed to eliminate the positions of **Coaches Director** and **Wrestling Developmental Director** and to add **Greco Development Director** and **Freestyle Development Director**.

Motion by Carol Saniuk and **second** by Debbi Kallai to accept the amendment as proposed by the Executive Committee. **Motion passed** by acclamation.

- A proposed amendment to Article 5.2 Directors was proposed to combine Sombro and Grappling with Beach Director.

Motion by Chris Kallai, Jr and **second** by Bob Vallarelli to accept the amendment as proposed by the Executive Committee. **Motion passed** by acclamation.

•A proposed amendment to Article 4.5 Vacancies was proposed to modify the procedure to fill a vacancy of an Officer from a vote of the entire voting body to a vote of the Board of Directors.

4.5 Vacancies If an Officer of the association resigns or is otherwise unable to serve, the remaining Executive Board shall place the names of the nominees for the vacant officer on a ballot which shall then be distributed by electronic communication to the Board of Directors. The Board of Directors will have seven (7) days to return a vote for the proposed officer. The vote will be official if 75% of the Board of Directors responds within the seven (7) day period and one candidate has a majority of the votes. In the event that 75% of the Board of Directors has not responded or there is a tie after the seventh day, the remaining Board of Directors will be contacted until the 75% response is achieved or the tie is broken.

4.5.1 will be eliminated

•A proposed amendment to Article 5.7 Vacancies was proposed to modify the procedure to fill a vacancy of a Director from a vote of the entire voting body to a vote of the Executive Board.

5.7 Vacancies If a Director of the association resigns or is otherwise unable to serve, his/her successor for the remainder of the term of that directorship shall be promptly voted into office by the Executive Board.

5.7.1 will be eliminated

•A proposed amendment to Article 7.8 Vacancies was proposed to modify the procedure to fill a vacancy of an At-Large Board Member from a vote of the entire voting body to not replacing them until the next Annual Meeting.

7.8 Vacancies If an At-Large Board Member resigns or is otherwise unable to serve, he/she will not be replaced for the remainder of the term.

7.8.1 will be eliminated

Motion by Bob Vallarelli and **second** by Wendel Donathan to accept the amendments as proposed by the Executive Committee. **Motion passed** by acclamation.

Articles 4.5, 5.2, 5.7, and 7.8 will be amended in our Constitution and Bylaws, distributed by email to all voting members, and published on the web site.

NEW BUSINESS

1. Online Membership card process

Last year was our first year to use online membership rather than paper. It was successful. In 2008, we are going to be moving towards online Club registration and by 2009, that and event sanctions must be done online. Leo distributed the directions for registering a Chartered Club online.

2. Kid/ Cadet/ Junior Regional 2008

USAWO will be hosting the K/ C/ J Regional on May 23-25th, 2008 at Battelle Hall in Columbus, OH. There will be 12 mats and online registration will be available. Try to keep that weekend available for working!

3. University/ FILA Cadet Nationals

USAWO will once again be hosting the University/ FILA Cadet Nationals, on April 10-13th at Akron University. Since Akron does not have a wrestling team, we are in need of more volunteers than usual to move mats and for mat workers.

4. Background checks

Beginning September 1, 2008, background checks will be mandatory for all coaches, directors, officers, pairing officials, mat officials, and anyone over 18 working with the wrestlers. Cost will be \$17/person and will be good for a 2 year period.

When registering online, you will pay for your membership card and background check at the same time. You will not be allowed on the floor without a Coach's card and you will not receive the Coach's card without the background check.

If you are a participant and a Coach, you will need to have 2 cards (as is now the case).

5. **Change tournament season length from 3-4 months**

This year we only have 4 weeks for Qualifiers due to the University/ FILA Cadets and the Regional at the end of May, which does not allow for many qualifiers.

The discussion would be for 2009 to have a Freestyle/ Greco season followed by a Folkstyle season. The OHSAA limitation was seen as a problem. Also the fact that Folkstyle officials are compensated differently than the Freestyle/ Greco officials could put a large financial burden on the host sites.

It was decided not to change.

6. **One man mechanics**

This is having one official on the mat and one keeping score. It is being proposed as a way to decrease the number of mat officials required for a tournament. This was tried at Fargo in 2007 and worked fairly well. The senior official was at the mat the entire time.

Motion by John Gramuglia and **second** by Bob Dies to allow two man mechanics at the USAWO Qualifiers at the discretion of the Tournament Directors. Close discussion **motioned** by Zach Ison and **seconded** by Tim Allen. **Motion failed.** USAWO Qualifiers will stay with 3 mat officials.

7. **Miscellaneous**

Joe Neely explained why he was so excited about Sombo wrestling. It is a good diversion for the athletes; it is considered a good time – a time to have fun. Athletes feel that they are doing something different but there are many of the same principles and moves. On October 13th, there will be a tournament in Covington, KY. Information about Sombo tournaments and information in general is available at www.somboJoe.com or from Jneely@fuse.net. There will be a Grappling/ Sombo Championship in the Ohio area in 2008.

Jerry Robinson from Rocky Mountain Nationals discussed the Terminator World Championships. 2008 will be the fourth year that this has been done in Ohio and the dates March 29th and 30th. The goal is to build the tournament to 3000 wrestlers. If USAWO agrees to support this tournament (with workers) then Jerry will make it a USAWO Qualifier and a USA card will be required for participation.

Bart Friedenbergl mentioned that the Tournament of Champions will be in Columbus April 26, 2008. There will be approximately 3500 wrestlers with 30 mats. He wanted to discuss combining Cadet/ Elite/ Open for Freestyle. Much discussion about division weight groups do not match up so that the TOC cannot be a qualifier. Freestyle portion will either by USA-sanctioned or AAU-sanctioned and a card of the appropriate organization will be required. This would provide another place to wrestle.

Bob Vallarelli announced that 10 mat officials have been recommended for upgrade.

Equipment buys were discussed. USAWO needs to purchase 2 clocks at approximately \$2500/ each to complete the set of 8 that we currently have. This will enable us to run large tournaments more efficiently and professionally. USAWO also needs to purchase 4 laptops over the next 2 years. These would be used for Officers (who are currently using personal computers exclusively for USAWO business) and for running tournaments (TRACK wrestling). **Motion** by Chris Kallai, Jr. and **second** by Zach Ison to purchase the two clocks and purchase the laptops. **Motion passed.**

Ralph Cubberly questioned the Junior National Team Selection process. He said that he was aware that the rules are not followed at the Junior level. **Motion** by Ralph Cubberly that a doctor's note or a statement from a school official that the wrestler is participating at a high school athletic event is the only valid reason to submit a petition. There was no second. Chris Kallai and Leo Saniuk promised to attend the Junior petition meetings to ensure that the rules are followed.

Bob Vallarelli proposed that each Tournament Director must get 2 NEW adult officials to participate or there will be \$100 paid back to the officials that do work. **Motion** by Bob Vallarelli and **second** by Pete Bolanis to require Tournament Directors to supply 2 new officials or there will be a penalty of \$50/ person. This was amended and accepted to be one new mat and one new pairing official. **Motion failed.**

Wayne Hiles spoke about having the National Team camps at OSU prior to Fargo. Tom Ryan, head coach OSU, has offered to have both the Cadet and Junior National camps housed, fed and trained at OSU; the OSU wrestling team will train and set up all mats for \$42/person/day. He felt that this amount could be negotiated. USAWO currently pays \$50/person for camp. A specifications letter will be sent to all Wrestling Universities by February 1 to get their bids. Supervision plan is a must; trainers, doctors and coaches will also have to be accounted for. John Cvetic and Wayne Hiles will put together a bid package, with help from Frank Baxter.

Motion by Leo Saniuk and **second** by John Gramuglia to raise the fee for wrestlers participating in both Greco and Freestyle at the Qualifier by \$5 from

both styles at \$20 to both styles at \$25. This would apply to Schoolboy/ Cadet/ Junior. **Motion passed** by acclamation

Motion by Chris Kallai Jr. to raise the admission price for \$2/adult to \$5/adult; \$1/child to \$3/child and family from \$5 to \$10 with the extra money going to the Tournament. There was no second. **Motion** by Carmen Armenta and **second** by John Gramuglia to raise the admission price to \$5/adult and \$1/child (with no maximum). **Motion failed.**

Motion by Carol Saniuk and **second** by Debbi Kallai to eliminate refunds at the Qualifiers. Tournament Directors will have the discretion to override if warranted. **Motion passed** by acclamation.

Information about Goldshield was distributed to help prevent mat diseases.

REQUIREMENTS / PROCEDURES FOR 2008 USA WRESTLING - OHIO TOURNAMENTS

1. Tournament Agreement Forms (i.e., contracts) must be returned to **Leo Saniuk** no later than December 1, 2007. If these are not returned by January 1, 2008, there will be a \$50 late charge assessed for each form that is late. Event Sanction Forms and Club Charter Applications must be sent by December 1, 2007 also.
2. Officials must be paid according to the Official Compensation Policy. If this is not done, the tournament will be fined at least the amount that the officials are underpaid and placed on a two-year probation. If the violation occurs again within that time frame, the tournament will be dropped from the USAWO schedule. Leo Saniuk will monitor this.
3. If there are not enough mats at the tournament based on the minimum number listed on the contract, the tournament will be placed on a two-year probation. If the violation occurs again within that time frame, the tournament will be dropped from the USAWO schedule. Leo Saniuk will monitor this.
4. Tournament Reports are due back to the **Leo Saniuk** within one (1) week of the tournament along with a check for the Junior/Cadet/Schoolboy entry assessment. If reports are late or the check is not included, a \$50 late fee will be assessed.
5. The tournament **MUST** have **CERTIFIED** medical person on site for the **ENTIRE** tournament.
6. USAW's insurance company recommends a pre-tournament site inspection of the facility. Tournament Directors will receive an inspection form with their tournament guides.
7. Be sure that you have at least two (and preferably three) working scales available.
8. Be sure that you have enough Mat and Pairing officials and enough help to sell USA cards, handle registration and weigh-ins, and work the tables.
9. Go over instructions with registration and weigh-ins **before** registration starts.
10. Cut off registration and weigh-ins at the designated times.
