New Business:

• Fees for Upcoming Season – There was discussion determining we will increase our fees for the 2013/2014 season with no discount for early registration. It was suggested that we incorporate the skate sharpening as well to streamline the process. There is also a plan to earmark the jersey monies.

Proposed Rates for Upcoming Season:

Mites - \$70 (\$60 registration & \$10 skate sharpening)

Squirts - \$135 (\$105 registration, \$10 jersey fee & \$20 skate sharpening)

PeeWees - \$170 (\$135 registration, \$15 jersey fee & \$20 skate sharpening)

Bantams - \$205 (\$165 registration, \$20 jersey fee & \$20 skate sharpening)

***Above rates are in addition to the fees paid online to USA Hockey

The HS skaters currently pay \$100 for ice fee and \$20 for skate sharpening. It is proposed they pay \$175 (\$155 ice fee and \$20 skate sharpening)

It was suggested that skate sharpening is \$5 per time for non association members. We should also discuss skate sharpening fees at the Joint Board meeting.
