The U8 girls should be billed like a mite and the U10 girls should have rates similar to a Squirt level player. We need to communicate with this association before any bills are paid.

OLD BUSINESS

Arena Update: None

Grant Update: Damion will look into a few grants and see what he can find out.

NEW BUSINESS

Sharing Mite Ice: Damion Johnson: USA Hockey, talked about breaking up ice space and because we don't have enough kids to make stations. Perhaps talk to other associations to have a cooperative practice. Make things a little more practical. Tom agreed that this was a good idea, but other associations are hard to sell to because they see it as imposing on their ice.

<u>Co-op:</u> Looking for a longer term deal, something more than 2 years. CI is asking for discussions. CI is on its last year with Mora. It's a two-way thing and both sides have to be willing and we're in a way on the outside looking in as we don't have any ice. Don made note that our biggest problem with CI is going A on every level; they're getting more realistic. If we can get on the same page there with them, that's the smartest option.

Pine City board said that they would talk about a potential co-op in the Spring. Chisago numbers are pretty strong, but we will reach out to them anyway. The objective is to get more kids playing and playing at the right level.
