Directors' Reports:

- Tony- website is an ongoing process – need content submitted to Matt
- Board will be able to update their own sites
- Bill – will be able to complete email blasts to all members of soccer club
- Mike Long – there is another Valley Soccer Club in the area – Bensalem area
- Kelly Update from Matt –
 - o Paypal account is set up for online registration, we are listed as charity, 2.2% charge +\$.30 per transaction, transfer will need to be completed manually from Paypal (Karen – another bank account to maintain)
 - o Exec Board Blog site ready to go
- General discussion – we will need to test detail that is received, how transfers work, etc. Need to Test and perhaps one travel team for Fall Registration

Mike Long – Was travel team financial policy created? Tony has distributed Financial Policy Guidelines (EXHIBIT C), this policy was approved by Executive Committee, Tony reviews policy, general discussion on policy and specific aspects of policy - Policy is effective as of 16th March 2011

Jamie Scott from Atlantic Soccer Factory makes presentation to Membership on their programs – they offer soccer camps/clinics for Clubs, Travel Teams

Ken P – Kick Wall approval – motion for Eagle Scott (Ben Ney) to build Kick-Wall at Phillips Field, general discussion on uses/purposes of kickwall – Carol May – any approvals needed from Phillips Family? Ken- not needed – Bill motioned, Mike Long seconded – All in Favor

Ken P – Need approval for Seeding Plan – Request funding of seeding plan of \$1,200 – Mike Long motioned, Jacki Watkins seconded – all in Favor

Carol May – TOPS Program – Presents the following updates/requests

Requests the Exec Board review making the proposed change to the Constitution and Bylaws by adding the following:

- **Adjustment to Article II...Purpose and Objectives –**
 - **Proposed adjustment – Section 3 –The Upper Perkiomen TOP Soccer (The Outreach Program for Soccer) program is a joint venture between the Valley Soccer and Upper Perkiomen Pee Wee Soccer Clubs. The goal of the Upper Perk TOP Soccer program is to foster an environment where young athletes with disabilities have the opportunity to learn and enjoy the game of soccer. We are designing the program based on guidelines put forth by US Youth Soccer the national governing body for youth soccer. The program will be offered to boys and girls between the ages of 4 and 19 who have a mental or physical disability. The program will be run by volunteers and include older children who participate in soccer either through one of the community clubs or through the community schools. The hope of the program organizers is to develop a sponsorship and donation program with recurring funds so families will not have to pay to have their child participate.**
- **2011 Outdoor Season**
 - **Will be held at Camelot Park in Upper Hanover Township, beginning Sunday, April 3rd from 3:00-4:00pm and continue through Sunday, October 30th, weather permitting. Our annual picnic will be held during this scheduled time and toward the end of the season. Thank you to Ken for scheduling the time for TOP with Upper Hanover Township.**
- **2011 Outdoor TOP Sponsorship**
 - **Carol has delivered 10 requests for sponsorship for this coming Outdoor season. TOP is requesting that any sponsorship monies received provide TOP with uniforms, pinnies, cones, and soccer balls in multiple sizes. If more than enough funds come in to cover the above requested, Carol requests that the Executive Board determines where and how the excess is to be applied and to please inform Carol of the decision.**
- **TOP Sponsorship Monies**
 - **In the effort to keep the TOP Soccer program a free program and to assist the Valley Soccer Club, Inc. with any incurred expenses for this free program, TOP Soccer is seeking its own sponsors. It is Carol's intent to collect enough sponsorship monies to cover any and all expenses of the TOP Soccer program and to assist in the costs to and maintenances for VSC. TOP Soccer does not need, nor want, to carry any type of monetary balance. The TOP Soccer program does want to participate in any fundraisers for VSC. A determination of where and how excess sponsorship monies, should there be any, needs to be made. TOP Soccer is an Intramural related program and it is Carol's request that any excess monies during the Outdoor season go to the Intramural program and that during the Indoor season the excess goes to the Indoor program.**
- **Barber's Septic Service**
 - **Carol is recommending to the Board that VSC continues to use the portable toilet services provided by Barber's Septic Service. The price we were given for the Indoor use (Jan 7-Mar 8) was \$175. This cost was covered through TOP Soccer sponsorship. The service Dale gave VSC was outstanding and I didn't hear even one complaint throughout the Indoor season about the condition of the unit.**
- **Newspaper Articles**
 - **An article has been written for submission to the Town & Country, Upper Perkiomen Chamber of Commerce, and Touchline recapping the indoor TOPS Season**
- **David – TOPS program was started as part of the intramural program – is there a request to separate the program from intramural? As of now will continue to be a part of the intramural program**

- Ken – asked if Carol has gotten our club listed as a TOPS club
- Karen – Request to obtain a laptop computer for use by Treasurer for maintaining financial records of the club
 - o General discussion on rationale behind request, Beth – raised issue where funds would be drawn from – Karen general funds
 - o \$600 requested for purchase of laptop and something to provide backup for information
 - o Bill motioned, Tony Seconded, Mike Long opposes motion – doesn't think it is wise use of Club's money, - All others in Favor
- Tony – Having Coaches meeting on April 13th - will review Travel Financial Procedures, tryouts, recruiting players,
 - o Fall team travel tryouts – want to advertise T&C, forms distributed at schools, signs
 - o Tryouts will be different than in past – Will use Middle School/HS Coaches to run stations, small sided games, scrimmages, Travel Coaches will only be required to evaluate players – Tony/Mike F to prepare checklist of what they should be evaluating players
 - o Hoping to get younger players and possibly backfill older teams
 - o Want to talk to intramural coaches – get them involved in developing travel players
 - o Looking to get more involvement from MS/HS coaches
- Beth – Need approval for
 - o 3 or 5 dozen hats (3 dozen +\$300, 5 dozen +\$450) – baseball hat with embroider; \$8 cost, sell for \$15, general discussion about cost – David – could this fall under spirit wear, where folks order it?
 - o Waterbottles - 100 units at \$1.11 per unit, expected to sell for \$3.5 or \$5, free shipping – Motion to purchase 100 waterbottles (general discussion) –
 - o Motion to order 100 waterbottles – not to exceed \$125 – Motion Kelly, Seconded Ken – all in favor
- Ken – All use of Finland fields must be registered through the Club – Ken needs to notify Marlborough Township
- Ken – inspected shed, need new roof, if anyone has personal property in shed they need to remove it, or it will become property of the Club,

Good of the Order:

- Mike Long – U11 Valley Strikers participated in Central Bucks indoor tourney – after being shut out their first two games, they came back and won three in a row to take 2nd place

Soccer Field Renovation 2011 (Proposal Presented by Ken P)

2.5 Acres

Step 1 Late March or April

Overseed with:

100 to 150 lbs/Acre of Sports Turf or similar mix plus

100-150 lbs/Acre of RPR Spreading Ryegrass or a Ryegrass blend.

Equipment needed for the overseeding:

☐ Tractor with slit seeder.... Josh G. from Butter Valley

☐ Tractor with broad cast seeder... Jeff from Sweet Water

Cost Break Down of Seed for 2.5 Acres Based on 150 lbs/Acre

The best seed selection would be as follows:

(Choose one of the two mixes)

Sports Turf Mix \$1.15/lb = \$431.00

Economy Sports Mix \$.95/lb = \$356.00

(Choose one of the two blends)

RPR Spreading Ryegrass \$1.40/lb = \$525.00

Basic Ryegrass blend \$.99/lb = \$371.00

Approximate seed cost would range from **\$727.00 to \$956.00.**

Fertilize with:

18-24-12 or similar starter fertilizer @ 4-5bags/Acre.

18-24-12, 50% SCU @ \$23.95/ bag

Cost for Spring Fertilizer

12 bags needed @ \$23.95 = \$287.00

I would also suggest purchasing maybe a half pallet of tall fescue sod to install on bare spots near goals. **The cost of this would be around \$50.00**

Step 2 Mid-Late May

Overseed and topdress thin spots and fertilize again. I would think we could apply the second application of seed and fertilizer for less than half the price of the original seeding. A lot will depend on what percentage of catch we get with the first slit seeding.

If possible at sometime try to deep Verti-Drain and apply sand.

Spray for weeds.

Apply lime at least 1000 lbs./Acre. This can be done in the fall and we may want to send in some soil tests for a breakdown of soil nutrients

Title :

Travel Team Finance

Procedures and Guidelines

Effective Date:

16Mar2011

Scope:

This procedure defines the procedures and guidelines recommended for management, control, recording, and reconciliation of team finances for the purposes of maintaining adequate team funding, allowing for appropriate uses of funding, generation of team revenues and funds, and reporting and reconciling funds with the VSC Treasurer. .

Responsibilities:

It is the responsibility of the Travel Team Head coach or designee, Asst Coaches or Team managers, and the VSC Treasurer to follow and adhere to the procedures and guidelines as set forth in this document.

Travel Team Finance Overview

Valley Soccer Club maintains a banking relationship with a local bank for the purposes of depositing funds and writing checks for team expenditures. The club provides support and to a small degree a financial buffer to travel teams. Travel teams, however, are required to maintain their own budgets and recording of funds, debits and credits. Each team is expected to maintain adequate funds, independent of VSC funds, for all expenditures through registration fees, uniform fees , fundraising, direct payments from team member families and, in agreed



upon instances, through “dues” paid by team member families to the team at intervals. Travel team expenditures during the year are typically: Tournament fees, VSC patches (handed out to opposing teams at “patch” tournaments), team events (ie parties), purchase of team equipment or clothing, winter league registration fees, spring travel league registration fees, replacement player passes and team league fines (given for late recording of game scores, red cards etc).

While the club supports and recommends participation in discretionary soccer activities, such as tournaments, training, winter leagues and spring travel, the procurement of the funds to support these activities is the responsibility of the individual teams.

Procedures and Guidelines:

Record Keeping and Reporting

All Travel teams are required to maintain individual accounts that are separate from the Valley Soccer Club General funds. At the beginning of each Fall season the VSC Treasurer will provide each team Head Coach, or designee, with a copy of the current balance in the teams funds as well as an accounting of last year’s actual cash flow. The VSC Treasurer will maintain a spreadsheet that tracks all Team expenditures, as checks written at the teams request, and income, as deposits of funds generated by the team, and upon request will provide that information to the teams.

Head coaches, or designees, are required to keep an adequate record of:

- payments made to them by team member families for the purposes of Player registration, uniforms, team tournaments etc
- expenditures made and paid for by VSC checks (ie payments for tournaments)
- collected monies deposited into the VSC bank (either deposited directly or given to the treasurer)

This will allow for reconciliation of funds should questions arise from the VSC Treasurer. Payments made by team member families should be kept and recorded individually so as to allow for reconciliation of discrepancies or questions.

It is recommended that the team’s designee use a spreadsheet to record team and family transactions.

Account Balances

All teams are expected to keep a positive balance, or minimally a zero balance, in their individual team accounts. During the initial fall registration period there may be a short timeframe where a negative balance in a team’s funds will exist. It is incumbent on the Head Coach of the team, or designee, to ensure that funds for registration and uniforms are collected promptly and deposited to reduce the deficit as soon as practical. Newly formed teams, such as U-9 teams, will be allotted a \$200 initial balance to allow for team initiation and the period where



systems to collect money and finance records are put into place. This starting balance will be deducted from collected monies as soon as available.

At times a team may be in a position where it's team funds are not sufficient to cover the costs of an impending tournament that may require payment before funds can be raised through typical channels. In cases of this nature it is incumbent on the head coach, or designee, to contact the VSC Treasurer and apprise them of the situation. VSC general funds may be allocated on an interim basis at the discretion of the treasurer based on the teams past history with finance management. In no instance will the club support a more than 1 tournament (~\$450 for small sided teams and \$650 for large sided teams) shortage.

Fundraising

All travel teams must raise sufficient funds to cover certain required costs such as registration fees and uniform costs. Participation in Tournaments, Winter leagues, training sessions, Spring Travel etc is discretionary, albeit supported and recommended by the Club Body, and as such require the raising of additional funds to support such ventures.

Teams may raise funds through direct payment for services by team member families (ie checks from families for registration or tournaments), periodic team "dues", fundraisers and sponsorships.

Teams are encouraged to seek additional funds through team fundraising efforts to offset the cost of tournaments and league fees. Fundraising can support a robust tournament schedule as well as off season leagues and offset costs of participation for team member families. All fundraising (with the exception of direct payment, "dues" and sponsorships), require permission from the VSC Executive Committee to avoid conflicts with other teams or club sponsored fund raising events. Recommendations for previous successful fundraising events can be provided on request.

In order to avoid duplication with the VSC intramural program, which relies heavily on sponsorships, teams are asked to avoid general canvassing for sponsors and confine their requests to employers, friends and other business' where team members may have relationships. A sponsorship request letter is available from the Travel Coordinator upon request.

Use of Funds

The use of funds raised (with the exception of those raised for registration and uniforms, or for a specific event – see exceptions) are at the discretion of the Head Coach. It is recommended that the usage be vetted by team member families but the final decision will be at the discretion of the Head Coach. Therefore, for example, participation in a tournament may not have 100% acceptance by all team member families but be approved by the Head Coach based on an assessment of the overall participation, the ability to roster a reasonable team, the benefits to the participating team members and costs. Team member families are encouraged to participate in the decision making process and head coaches are encouraged to use a reasonable measure to determine the best decision for the team. It is recommended that guest and secondary should not be charged for tournaments in which they are asked to play to supplement a team's roster but the decision whether to charge or not will be at the discretion of the head coach.



Funds are typically required to pay for tournaments and off season league registration fees (ie winter and spring leagues). Teams can also use the funds at their discretion to pay for specialized soccer supplies (ie soccer bags, futsal balls) or team clothing (sweatshirts, t-shirts, warm up suits) or team sponsored gatherings.

Payments and Deposits

Payments

Teams are required to channel all payments for outside expenses through the clubs checking account system. Requests for checks accompanied with receipts or documentation for recording use should be given to the VSC treasurer for the generation of a payment check. Checks will be made out to the organization that the service or time is being supplied by (ie tournament sponsor). Teams requesting checks should make the request at least 5 working days in advance of needing the check as 2 executive Board member signatures are required.

Deposits

Deposits to the teams fund account can be made by delivering payments and checks to the VSC treasurer for deposit. The treasurer can also supply teams with deposit slips and teams can make their own deposits. The VSC treasurer should be informed of the origin of the funds.

Team Member Expectations

Members of travel teams agree to participate in a team sport upon registration. As such individual team members agree to abide by decisions made by the teams Head Coach and implicitly ratify any decision made and revoke all individual rights to dispute the decision. After a team decision has been made by the teams head coach that decision is final and binding on the team as a whole. Individual team members have the right to, and are encouraged to, make their voice and opinion heard during the pre-decision phase.

Likewise all teams' funds generated either through dues, direct payment, or fund raising are the assets and holdings of the team and no individual team member has any rights to any monies whether by decision not to participate in a team event nor upon decision to leave the team. Upon leaving a team a team member forfeits all rights to any funds currently in the teams funds account.

Exceptions

Fronting of funds for use

In the case of tournaments that require credit card or on-line payments, or very short lead times for registration head coaches, or team designees, may pay with personal checks or credit cards. Every effort should be made to avoid this situation but if necessary upon agreement from the VSC treasurer personal accounts can be used. The same requirements for documentation of use of funds apply as normal.

Use of funds outside of typical travel team expenditures

The expectation for the use of funds is that the event or use is a reasonable use and that a decision to go ahead with such use would not be an undue burden on the team members. Therefore, any tournament that requires an



entry fee greater than typical fees (ie \$300-450) or that require families to commit to expenditures outside of car travel (ie overnight or multiple overnight lodging accommodations) or expectations of additional costs not associated with soccer itself (ie amusement park fees etc) shall be funded only through direct payment for participation by those team members that have agreed to participate or a fundraiser designated specifically for this purpose (An example of such an expense is the Annual Beach Blast Soccer Tournament held in Wildwood NJ).
