Ice Usage

At this point we have two teams that are behind in ice time: 14U and Bantam B. This will be caught up in February.

The total OYHA hours through December does include tournament ice charged to OYHA. Last season: \$68,000 (July 1 – January 15, 2013) This season: \$71,000 (July 1 – January 15, 2014)

Parent Meetings – coaches should be holding the 2nd half parent meetings in the next few weeks.

Dryland – tough to schedule teams more than once a week. We have worked with Steve to make sure the arena staff understands that coaches have permission to take kids to the dryland center even if not scheduled.

OYHA has booked summer ice, which will be split between a girls camp and a boys camp.

Girls Program – we are going to start with a small group meeting including representation from each age group- most likely coaches. This group will begin by brainstorming ideas for next year.

Tournament Committee:

Squirt Tournament remaining: Eric, Bob, and Tom are Tourney Directors

The brackets are available and tournament is full. We did allow one team at $\frac{1}{2}$ price just to get the tourney filled.

District/Regional Teams: work hours Bantam A, Bantam B Squirt A Blue, and Squirt B

Blue Line Medical - easy to work with, very efficient, active and visible staff,

Only one written tournament complaint has been received and it was really a complaint about a player on another team.

Park & Rec would like to be able to use the dryland center with the Level 3 & 4's. This was approved.
