Motion RE #2 (M/S/P): To remove the following wording from the Recruiting policy, Contract Signing Dates:
 The RMR will only recognize signed contract between players/parents and clubs in regards to RMR Policies
 according to the following dates:

Ages 15 and Below On or after the third Saturday of October Ages 16 and Above On or after the first Sunday of November
```

- Motion RE #3 (M/S/P): To add the following wording to the Recruiting policy, Contract Signing Dates: The RMR will recognize signed contracts between players/parents and clubs in the RMR policies according to the date of the contract starting the day after the last day of competition for the Girls Junior National Championships for the previous season. The Boys division will also start the 1st day after the last day of competition for the Boys Junior National Championships for the previous season. Coaches will also adhere to the contract signing date.
- Motion RE #4 (M/S/P): To add the following wording to the Recruiting policy, Non-Recruitment Period: The time period for coaches and junior players (Boys & Girls) is the contract signing date or December 1st (whichever comes first) through the last day of competition of the Girls/Boys Junior National Volleyball Championships.
- Motion RE #5 (M/S/P): To remove the following word (designated) from the Recruiting policy in the section "Publications and Web Site Posting". It will now read as follows. Published Rosters and Members List on website or other printed material is limited to current, alumni members, or after the designated contract signing date for the new season (roster) of that club.
- Motion MOH #1 (M/S/P): The following will wording will be removed from the Members On Hold (MOH)
 Policy. The RMR will only recognize signed contracts between players/parents and clubs in regards to the RMR
 Membership on Hold Policy according to the following dates:

Ages 15 and Below: Contracts signed on or after the third Saturday of October Ages 16 and Above: Contracts signed on or after the first Sunday of November

• Motion MOH #2 (M/S/P): The following wording will be added: The RMR will recognized signed contracts between players/parents and clubs based on the contract signing date as long as it is the date after the last day

of competition of the Girls/Boys Junior National Volleyball Championships or December 1st of the current season, which ever date comes first.

- Motion MOH #3 (M/S/P): In order to use the Members On Hold policy the club director must complete the following.
 - ◆ All individuals who sign contracts between the date after the last day of competition of the Girls/Boys Junior National Championships and August 31st of that time period are required to have the individual become a member of the RMR − USAV and affiliated to that club in the Webpoint system by midnight on September 30th of that current season.
 - ◆ All individuals who sign contracts between 9/1 and 11/30 of the current season are required to have the individual become a member of the RMR − USAV and affiliated to that club in the Webpoint system by midnight on November 30th.
 - ♦ All individual that sign contract after 12/1 of the current season are required to have the individual become a member of the RMR USAV and affiliated to that club in the Webpoint system no later than 5 business days after the contract signing date.
 - ♦ It is the sole responsibility of the Club Director to confirm within the Webpoint system that the individual has complied with above requirement. Failure to do so will void the placement of the individual to the Members on Hold Policy.
- Motion MOH #4 (M/S/P): The deadline date to place an individual's name to the Members On Hold Policy has been changed to July 15th of the current season.
- Motion MOH #5 (M/S/P): The wording will be changed: All clubs must refuse any player on the Members On Hold List to be rostered on a team and not allow them to participate in any club activity until their name has been released. Failure to comply will result in sanctions to the club.
- Motion INT #1 (M/S/P): Club Staff and Player Intent & Commitment will read as follows (changes are underlined): There is a "No Transfer" policy in the Rocky Mountain Region (RMR). The RMR is committed to providing a quality program to all junior players in the Region. Given the RMR's commitment we expect that all club staff, players and parents demonstrate their commitment to the Junior Club program of their choice. Club Staff, players and parents also understand that once an individual has committed to a club, they are affiliated to that club for the entire RMR season (Effective dates for Coaches and Junior Players is the contract signing date or December 1st (whichever comes first) of the Current Season through the last day of competition of the Girls/Boys Junior National Volleyball Championships which is ever is applicable). Individuals may not change club affiliation prior to the conclusion of the designated season for any reason. This would include, but not limited to, post season competitions including the AAU Championships, Volleyball Festival as well as any other competitions organized by any USA Volleyball affiliated organizations.
- Motion BEACH #2 (M/S/P): Create a RMR Beach Ranking system that will award players with points as individuals based on the results of a RMR Beach Series Event.
- Motion Boys #1 (M/S/P): Research the possibility of a boys 4 vs 4 league in September and October using the USAV league membership process and facilities such as 303, CVA and Club 5280 as sites. Offer this at a low cost. If not for 2013 but for 2014 for sure. Funding will be requested.
- Motion Boys #2 (M/S/P): play for boys in the RMR Beach Series programming.
