Julie is also in the process of getting bids to rebuild the pull tab booth at Buffalo Bar and Grill. A BYHA member is willing to do the labor for free in exchange for volunteer hours. A motion was made by Brian Swenson and seconded by Glenn Kothrade to approve materials up to \$5000 to replace or repair the gambling booth. Julie is also requesting a new computer that would be used only for the gambling information. It would be more secure than the current personal system that she uses. Brian will price options for the next meeting. Julie has met with the auditor. A formal report will be given to use, but the initial meeting went well. The auditor did give her some suggestions for resuming a raffle: We could sell tickets at games and tournaments. We could also do raffles at Buffalo Bar and Grill.

Meeting was called to order by President Stephanie Kohnen at 7:12 p.m.

President's Report:

We will need a new D5 representative to replace Steve Pearson, who has new responsibilities with D5. They meet in Kimball once a month on Wednesdays.

Treasurer Report:

Our current balance is \$127,00 with \$7000 in outstanding checks for a balance of \$120,000. Full report on file for review. We have already \$50,000 marked for the 2014-2015 building loss due to the city of Buffalo and another \$50,000 to use for ice feels next season. These funds were transferred from the gambling fund to our general account. The treasurer's report was approved by Glenn Kothrade and seconded by Brian Swenson.

Kris has talked with the Maple Grove Hockey Association regarding how they handle financial hardship. They use an income threshold and then require families to provide tax forms and an application. Will table discussion on funding and criteria for this program with the hope of implementing something for the 2014-2015 season.

Secretary Report:

A motion to approve the was made by Heidi Sohler and seconded by Brandon Ruiter Approved 8:0.

Tournament Report/Volunteer:

Koren presented proposed dates for the 2014-2015 home tournaments. A motion was made to approve the dates as proposed, pending the approval by the Girl's Director. Motion made by Brian Swenson and seconded by Glenn Kothrade.

Manager Report:

Volunteer Report:

Hockey Operations Report:

A motion was made by Blake Palme and seconded by Kris Holthaus to approve the amended tryout procedures and to keep the tryout policy separate from the handbook. Approved 8:0. The current squirt tryout procedures may change depending on the recommendations of the new coordinator.

The following people are recommended for these positions: Mite Coordinator,: Mike Ennis, Squirt Coordinator: Brad Rassmussen, Coaching Coordinator: OPEN, Vice President: Bob Driver, and Player Development: Brian Braccini and Dave Carrothers. A motion to approve HOC candidates was made by Blake Palmer and seconded by Brandon Ruiter

Goalie Clinics:: Pro Hybrid has decided not to run their clinics here this summer.

Surveys are complete. We will utilize the information from the results when preparing for the next season. Dave Carrothers and Brian Braccini will manage the 500 program for next year.

Marketing:

High School Scholarships: Sally O'Borsky has contacting the coordinator at the high school and the business manager in charge of the 877 Foundation account. BY-HA has money in a fund that was designated for scholarships several years ago. The school has continues to give a \$250 scholarship each year, but the principal balance of the account is now down to \$6000. Nobody on the current board was aware of this fund and therefore the fund has not been added to , so the district has needed to use the principal balance for the scholarship. BYHA voted via email to increase the scholarship this year to \$500. We will add two additional scholarship for 2014/2015 and will determine the best way to sustain this account so that we can continue to offer scholarships each year.

Rink Writer: This is a computer program that would replace our current paper scorebook system. It is easy to use. It would upload rosters from the teams web page, provide stats. It would require a laptop and printer. The lifetime fee is \$350 for an arena license. This could also be used by the high school.

New Business:

Budget: The budget committee, consisting of Brian Stephanie and Kris, will meet on May 27th to work on the budget for next year. The feedback on increasing the hours for skaters this year, was overall very positive and the ice scheduler was able to fit all of the additional hours into the schedule.
