Gambling Report

- -Mr. Hosford stated that April went well. There was a \$7,152.00 profit before taxes. The tax rate will be going from 27% to 36% next month. There is a compliance meeting next week.

President Report

- -Mr. Jenkins will discuss with each person on the board what they would like to do for the board for the season. It was mentioned that going forward, there may not be one set person handling each item such as tournaments and fundraising. More of a committee set up will be the focus for the new season along with getting the members of the association more involved at the upper levels rather than just volunteering for open opportunities.
- -Chad Sexauer would like to come to the next meeting to discuss SSPYHA possible role and/or help with the new high school locker rooms.
- -Mr. Jenkins will talk to Mississippi Pub again about the possibility of housing our pull tabs.
- -Mr. Jenkins said that there is a possibility that we may have an opportunity to run the concession stand at Wakota next year. Research is being done regarding insurance coverage for the volunteers who would work there, whether children would be allowed behind the counter, and if there would need to be one person who is paid to manage the facility.
