## Carolina Courts Release and Waiver of Liability

**PLEASE READ CAREFULLY! THIS IS A LEGAL DOCUMENT THAT AFFECTS YOUR LEGAL RIGHTS.**

This Release and Waiver of Liability (the "Release") executed in favor of Court Sports Inc, dba: Carolina Courts, a for profit corporation, their directors, officers, employees, and agents (collectively, "Carolina Courts").

I hereby freely, voluntarily, and without duress execute this Release under the following terms:

**Release and Waiver.** I hereby release and forever discharge and hold harmless Carolina Courts and its successors and assigns from any and all liability, claims, and demands of whatever kind of nature either in law or in equity, which arise or may hereafter arise from any Volunteer Activities in which I engage with or for Carolina Courts.

I understand that this Release discharges Carolina Courts from any liability or claim that I may have against Carolina Courts with respect to any bodily injury, personal injury, illness, death or property damage that may result from my Activities with Carolina Courts, whether caused by the negligence of Carolina Courts or its officers, directors, employees, or agents or otherwise. I also understand that Carolina Courts does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

**Medical Treatment.** I hereby release and forever discharge Carolina Courts from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with my Activities with Carolina Courts.

**Assumption of the Risk.** I understand that the Activities includes work that may be hazardous to me. I hereby expressly and specifically assume the risk of injury or harm in the Activities and hereby release Carolina Courts from all liability for injury, illness, death or property damage resulting from the Activities.

**Insurance.** I understand that, except as otherwise may be agreed to by Carolina Courts, in writing, Carolina Courts does not carry or maintain health, medical, or disability insurance coverage for or on behalf of any Volunteer.

**Photographic Release.** I hereby grant and convey that unto Carolina Courts all right, title, and interest in any and all photographic images and video or audio recordings made by Carolina Courts during my Activities with Carolina Courts, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

**Other.** I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of North Carolina, and that this Release shall be governed by and interpreted in accordance with the laws of the State of North Carolina. I agree that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
