# MEETING OF THE OSSEO MAPLE GROVE ATHLETIC ASSOCIATION BOARD OF DIRECTORS

Call to Order: The meeting was called to order at 9:03 pm by Jason Green.

**Attending:** Attending the meeting were Robin Dreyer, Jason Green, Jamey Larson, Dan Sanford, Paul Sperl, Angela Lindblom, Curt Barker, Chris Sullivan, Joe Lavin, Mark Pallansch and Dave Ditty. Guests include Katie Lallier from Park & Rec and Mike Parenteau.

**Open Forum:** Former Coach, board member, and active OMGAA Advisor, Mike Parenteau spoke a few moments about his history and experience on the board as well as his passion for baseball and offering help when needed. In the past few months he has been asked by numerous board members for assistance on various issues, questions and concerns. He emphasized that board members should make sure they are serving for the long term goals for each and every league. He advised that if the board cannot look at where the association is today, they won't be able to determine where they are going in the future. Mike also recommended putting 2014 to a close, set an agenda to discuss the bylaws and the policies, discuss what works and what doesn't, and revise the program to make it better. There is no need to hire an attorney to review bylaws and policies as they are not legal documents but are enforceable via board membership. Lastly, he suggested reviewing the objectives of the House programs and reach out to as many house program members for input, past Directors and local coaches.

**Park & Rec:** Katie asked if the board decided that OMGAA would maintain the batting cages at Rice Lake. The city has received complaints about the condition of the cages. The board will take care of the cages asap. She also requested the number of teams from last year. The team counts are 38 for Junior House, 13 for Junior Travel, 13 for Senior Traveling, 27 for Senior House, 19 for Fastpitch House, approximately 8 for Traveling Fastpitch and 5 for adaptive softball. The new park superintendent is working with staff on cleaning the fields, focusing on weed control and edging the fields. Robin mentioned that the ice packs are on the back shelf in the storage shed if coaches need them and Dave dropped off scorebooks from Dicks.

#### League Directors -

Junior House: Not present.

**Senior House:** Paul distributed budget for all Star Tournament.

**Junior Traveling Baseball**: Partial refunds will be coming in due to rainouts. A link has been added on the Storm website for Fall baseball via Park & Rec. Osseo High School had a baseball clinic which was well attended by area youth. The head coach would like to do more going forward. MYAS needs a host for the 14AA state tournament, 8 fields are needed, same weekend as most other team tournaments. Jamey communicated to MYAS that this year we would not be able to take this on.

Senior Traveling Baseball: Umpire situation is in order.

**House Fastpitch:** Coaches from the Senior League are getting together with Wayzata for a round robin at the high school and asked if a waiver is needed for insurance purposes, which it is not. There's team that in the League that is frustrated with their performance. Curt asked for advice or input. Chris suggested scrimmages with other teams to help work on their development.
