### **COMMITTEE UPDATES**

#### **Executive Committee:**

In July of each year the Executive committee will meet to review volunteer positions and make recommendations for granting concession hours. Hours will not be granted in exchange for outside services provided.

A request was made by Colleen for help with completing the gambling audit.

The Otto Bremer Bank Grant was awarded for \$7500 for use for the dryland. There is some follow up that needs to be done as part of the process.

\$4000 balance owed on the dryland

#### **Education & Development Committee:**

Squirts and Peewees will start earlier this year, which is the same time as the girls and Bantams, around October 1.

Grant available for the rink dividers. Storage is still a concern

U14 Girls' Program options are still being investigated

Potential "Try Hockey for Free" in October

Squirts and U10 will practice together from October 1- December 1 and play in-house ½ ice games. This practice time will also be used to as a try-out to determine squirt teams, with evaluators looking at players ongoing throughout the 2 month time.

Suggestion was made to have an end of the year OYHA mixed teams all levels tournament.

Fall Camp will happen the 4 weekends in September, later evenings as not to conflict with other activities. Will need to finalize who will run fall camp.

### Equipment

Committee continues to work on updating forms

OYHA is no longer purchasing goalie equipment for players

Tracking of equipment: ongoing

Budget needs: jerseys, medical supplies, pucks

### Merchandise

Missy and Dana will continue to run merchandise.

### **Tournament Committee:**

Returning coaches need to start looking at potential tournaments. The board will possibly have to look at tournaments for teams where coaches aren't returning.

Home tournaments have been finalized and submitted to Let's Play Hockey for publishing in July, August, September, and October. Johnny and Beth are finalizing the launch of the website.

OYHA is working with Federated on Fair Parking (58 hours)

### Park & Recreation Committee:

Discrepancy in budget/ expenses has been resolved.

### New Business:

Freezer/ Laptop discussion: Julie can order the laptop. The freezer needs to be ordered, received and in the concession stand before the fair. The approximate cost will be \$2000.
